## Erratum: Fish community change in Lake Superior, 1970–2000

In the caption of Fig. 6, species names were incorrectly associated to the figure panels. The correct associations are as follows:

**Fig. 6.** Biomass of lake whitefish (*Coregonus clupeaformis*) (a), bloater (*Coregonus hoyi*) (b), kiyi (*Coregonus kiyi*) (c), ninespine stickleback (*Pungitius pungitius*) (d), burbot (*Lota lota*) (e), slimy sculpin (*Cottus cognatus*) (f), spoonhead sculpin (*Cottus ricei*) (g), and deepwater sculpin (*Myoxocephalus thompsoni*) (h) in U.S. (□) and Canadian (●) waters determined by lakewide bottom trawl surveys in nearshore waters (15–100 m), 1978–1999 conducted by the U.S. Geological Survey.

Similarly, various references to specific figure panels in the text need to be corrected as follows:
