Keeping Medicare Fee-for-Service Providers Informed through E-mail

Let CMS keep you up-to-date!

In the fast-paced, ever-changing world in which we live, it's all too easy to find yourself inundated with information. The Centers for Medicare & Medicaid Services (CMS) offers a way for you to receive consistent and accurate information regarding recent news, policy changes, and updates: **CMS E-mail Subscription Service**. Also referred to as listservs, these electronic mailing lists enable you to receive e-mails about the latest CMS Fee-for-Service (FFS) initiatives. All that is required to subscribe is your name and a valid e-mail address. Once you have a subscription profile, you will get updated information on the items of interest to you automatically without having to return to the website and check for changes.

There is a CMS Mailing List for everyone! To subscribe, visit the CMS Mailing Lists web page at <http://www.cms.hhs.gov/aboutwebsite/emailupdates/> on the CMS website to see all available mailing lists. Once you decide which subject areas you are interested in, just scroll down to the **Related Links Inside CMS** and click on the e-mail updates subscribe link. This link will allow you to sign up for updates or access your subscriber preferences.
