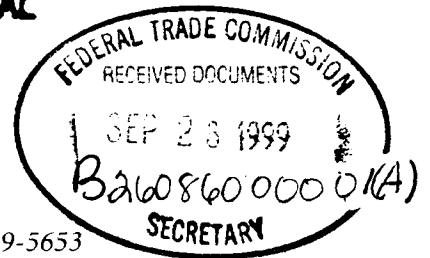


Sir,

I request the following change to above rule as follow:

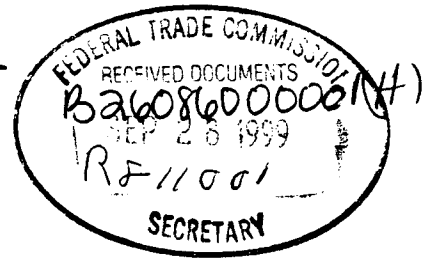
