Active ingredient: Nitrofurantoin

Form/Route: Suspension/Oral

Recommended studies: 1 study

Type of study: Fed

Design: Single-dose, two-way, crossover *in-vivo*

Strength: 25 mg/5 mL

Subjects: Healthy males and nonpregnant females, general population.
