Notes:

1. For the purposes of small group sessions, participants will be pre-assigned to a small group. Each group will have 10-15 participants. Pre-assigning participants to a small group ensures that the composition of each group is balanced with respect to both number of members as well as participant background, interest, and expertise.
2. Each small group will have the benefit of a professional facilitator who will assist the group with process management and recording. Questions to frame but not dictate the nature of deliberations will be posed by each group's facilitator which will ensure consistency across deliberations and promote synthesis.
3. In both small group and plenary sessions, participants will be encouraged to fully and frankly deliberate the subject matter under consideration. Facilitators will create an environment where all participants and views are respected. Moreover, consensus as to views and outcomes is not a goal of this Workshop. It is anticipated that the outcome of the Workshop will be options for the future structure / mandate of the GLBTS regarding the GLWQA and Annex 12 and possible new GLBTS management options for addressing new substances of Great Lakes concern and as such may reflect both majority and minority views; consideration of all views is warranted.
