OWH supports NIH SCOR Initiative

In September, the NIH Office of Research on Women's Health announced the new Specialized Centers of Research (SCOR) on Sex and Gender Factors Affecting Women's Health. Eleven institutions will share a total of \$11 million per year for five years. The centers will conduct research on vital women's health concerns such as metabolic disorders, osteoporosis, mental health, and pain disorders. OWH was proud to collaborate with NIH to support this important research initiative.

Outreach Initiatives

Nationwide Outreach Initiative with FDA Field Staff

In January 2007, OWH launched a new nationwide collaboration initiative. The aim of the initiative was to work with FDA field staff to develop collaborations with local organizations in urban and rural communities across the country. These organizations would help OWH get critical health information to women and their families through a variety of community and church events, adult education classes, health programs, and web outreach.

OWH provided funding to 18 FDA Public Affairs Specialists (PASs) who traveled around their regions to meet organizations, distribute OWH consumer health materials, and speak/ exhibit at conferences. Phase I of the initiative ended in September. To date, the PASs have collaborated with over 75 groups, including state and local health departments, community groups, universities, hospitals, and local businesses. Sample collaborations include:

OWH and AWHONN hold Nurses' Stakeholder Meeting

On September 18, OWH partnered with the Association of Women's Health, Obstetric, and Neonatal Nurses (AWHONN) to host an information gathering meeting with 20 national nursing organizations. The goal of the meeting was to discuss strategies for working with nurses and nurse practitioners to disseminate FDA health information to women. This meeting was the final in a series of three meetings designed to create women's health information networks. OWH met earlier this year with leaders from women's groups and organizations that serve Spanish-speaking communities.

Online Course on Breast Cancer Detection

Medscape from WebMD is offering an online CME course called "Follow Up of Abnormal Clinical and Imaging Findings of the Breast: Five Self-Study Modules for Primary Care Clinicians". The course is designed to educate healthcare providers on the early detection of breast cancer. It includes five modules on anatomy, health history and clinical breast exams, abnormal clinical findings, biopsy methods, and risk management.

Co-authored by OWH medical officer, Joseph Kaczmarczyk, the course was developed by Medscape, CDC, and ACOG in consultation with the FDA. The course is open to registered members of Medscape. (Registration is FREE.)

New Drug Safety Newsletter

In September, FDA launched a new quarterly newsletter for health professionals. The **Drug Safety Newsletter** aims "to enhance communication of new drug safety information, raise awareness of reported adverse events, and stimulate additional adverse event

reporting". The newsletter is designed to alert providers to postmarketing safety signals detected through reviews conducted by the FDA Center for Drug Evaluation and Research (CDER).

Lead Levels in Lipstick

The FDA is aware of reports regarding lead levels in lipstick. FDA analyses to date have not supported the concerns about lead. However, the agency is looking into the specific details of recent reports and will need to independently confirm this information to determine what action, if any, needs to be taken.

Under the Food Drug and Cosmetic Act, FDA can take regulatory action against cosmetics deemed to be "adulterated". The Act does not give the FDA legal authority to require that cosmetics be approved before they go on the market. The Act does require premarket approval for color additives – including those used in lipstick.
