



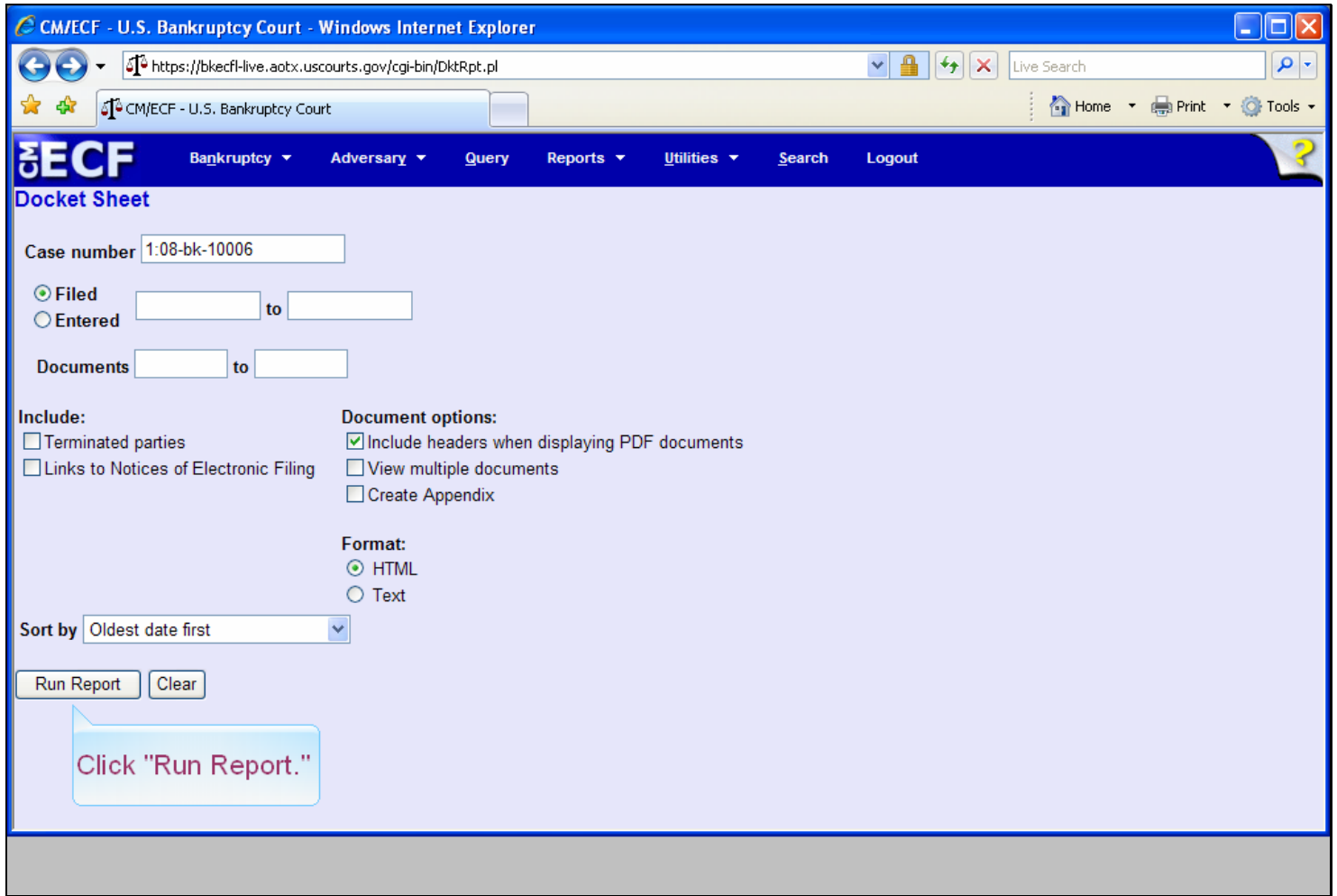

Release 3.2 can now provide a header for each page of a PDF document that includes this data. We will take a look at this feature now. 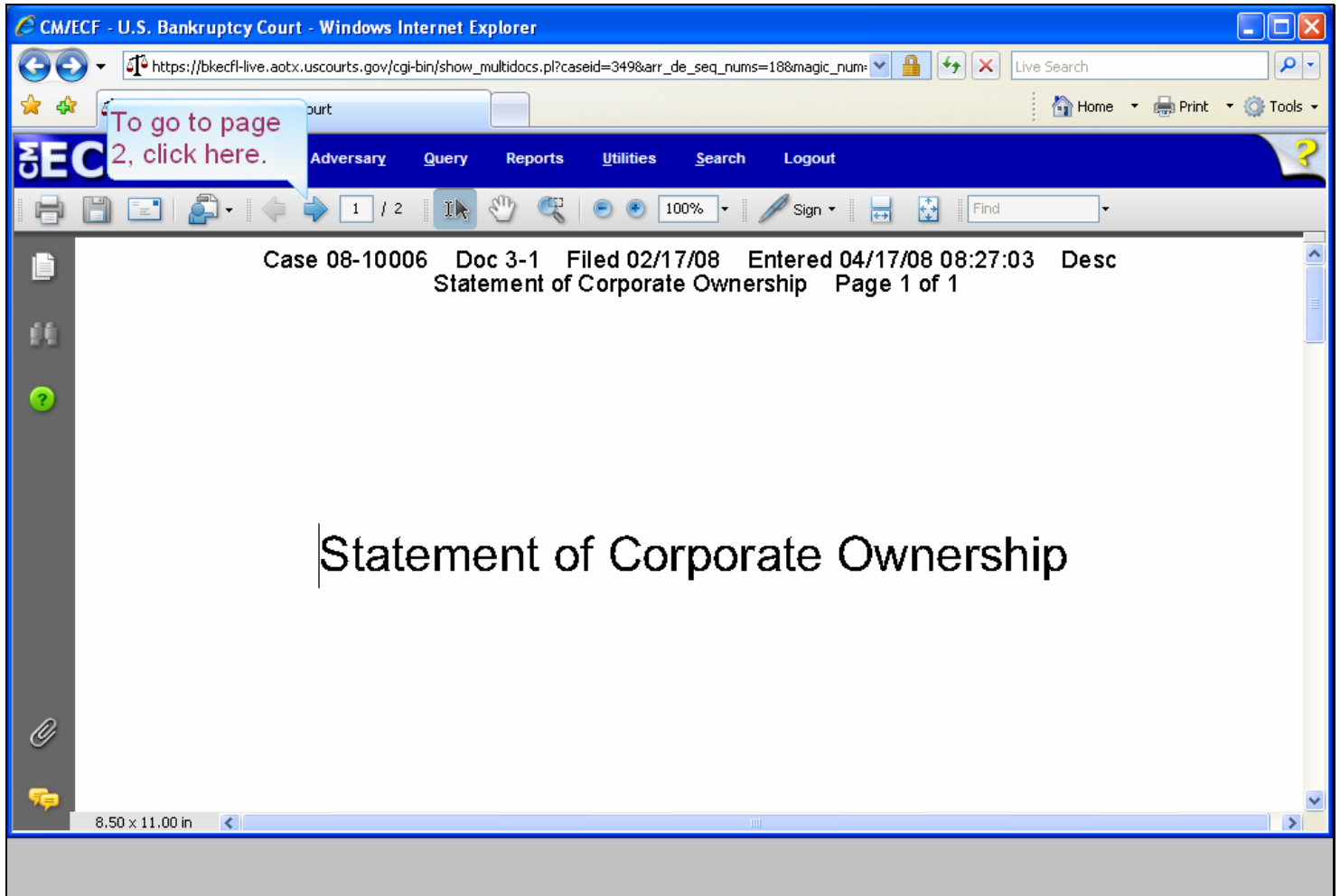
