Q. HOW MUCH NOTICE TIME SHOULD BE PROVIDED WHEN FILING A MOTION TO REOPEN CASE TO AVOID A LIEN?

A. A NOTICE PROVIDING 15 DAYS RESPONSE TIME WITH SERVICE ON THE LIEN HOLDER SHOULD ACCOMPANY THE MOTION.
