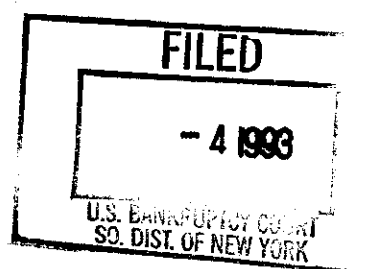
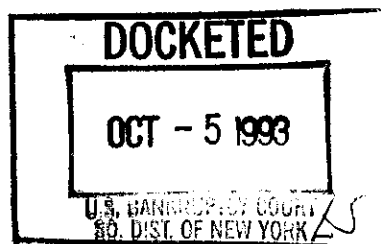
ORDER

WHEREAS, Robert M. Fisher, is a Chapter 7 Panel Trustee in the Southern District of New York appointed by the United States Trustee, and is eligible and available to serve in cases under Chapter 7 of Title 11 to which he may be assigned; and


WHEREAS, all mail addressed to a corporate debtor is property of the debtor's estate pursuant to §541 of the Bankruptcy Code and may be a valuable asset to the administration of a debtor's estate; and upon a showing of proper proof of appointment by the United States Trustee in a particular Chapter 7 case, a Trustee in a Chapter 7 case would be entitled to obtain mail addressed to such corporate debtor from the United States Postal Service; it is hereby

ORDERED, that upon presentation by Robert M. Fisher as Trustee of his appointment by the United States Trustee in a Chapter 7 corporate bankruptcy case to the United States Postal Service requesting that the mail be directed



to him as such Trustee, the United States Postal Service
is hereby ordered and directed to redirect such mail to the
Trustee until further order of this Court.

TO THE HON. BURTON R. LIFLAND, CHIEF BANKRUPTCY JUDGE:

The application of Robert M. Fisher, respectfully represents:

1. That applicant is a Chapter 7 Panel Trustee in the Southern District of New York and is appointed by the United States Trustee to serve in various cases under Chapter 7 of Title 11.

2. That immediately on August 24, 1993, the undersigned Trustee contacted the postal authorities in an effort to have the mail of a debtor redirected to the Trustee.

3. That the mail of the corporate debtor is property of the estate pursuant to §541 of the Bankruptcy Code, and may be a valuable asset of the estate.

4. That applicant has attempted to have the mail redirected since that time and has recently been contacted by the Office of Field Legal Services for the United States Postal Service.


5. That pursuant to the Court rulings In re Benny, 29 B.R. 754 (N.D. Cal. 1983); In re Crabtree, 37 B.R. 426, 430 (Bky. E.D. Tenn. 1984); In re Coats, 53 B.R. 64 (Bky. N.D. Tex. 1985), the United States Postal Service has requested an

order of the Court authorizing the United States Postal Service to redirect the mail of the corporate debtor to the Trustee.

6. That in view of the aforementioned, the attorney for the United States Postal Service has requested an order to be held on file for the undersigned Trustee for the reasons herein stated.

WHEREFORE, applicant prays for the annexed order for which no previous application has been made to this or any other Court, and for such other and further relief as to this Court may seem just and proper.


