Pursuant to the Order dated April 17, 1996 of this Judicial Council, by which the subject Bankruptcy Appellate Panel Service has been established in this circuit effective July 1, 1996, the Judicial Council hereby makes appointment to this Service as indicated below. - Judge Robert E. Littlefield, Northern District of New York, at Albany


