A duly constituted meeting of the United States District  
Judges for this District having been held on October 11, 1979,  
and it there having been concluded that the Local Bankruptcy  
Rules enacted by the Judges of this District from time to time  
should be repealed, and that the Bankruptcy Judges for this  
District have the authority to reenact such Local Bankruptcy  
Rules to the extent they will be consistent with bankruptcy law  
and practice,

NOW, it is

ORDERED that the entire body of Local Bankruptcy Rules  
for this District, as heretofore promulgated by the District  
Judges of this District through September 30, 1979, be and they  
are hereby repealed, and it is further

ORDERED that to the extent the Bankruptcy Judges of  
this District conclude that Local Rules should be promulgated  
for the practice and procedure of bankruptcy on and after  
October 1, 1979, such Bankruptcy Judges be and they are hereby  
authorized to reenact in whole or in part such Local Rules,  
and it is further

ORDERED that such Local Rules promulgated by the  
Bankruptcy Judges of this District shall be reported by the  
Bankruptcy Judges to the District Judges comprising this court's  
Bankruptcy Committee and to the Chief Judge of this District  
and shall take effect, unless amended or nullified by the  
District Judges of this District, not later than the expiration  
of twenty business days after such Rules have been thus reported.
