An order of this court having been entered on the resignation of Stanley T. Lesser as a bankruptcy judge for this district, wherein bankruptcy cases theretofore referred to him were referred, in random order, to Bankruptcy Judges Ryan, Babitt, Galgay and Lewittes, and Burton R. Lifland having been inducted as a bankruptcy judge for this district at a special session of this court held on March 28, 1980 as successor to Stanley T. Lesser, and it appearing that those bankruptcy cases originally referred to Stanley T. Lesser and re-referred upon his resignation should now be re-referred to Bankruptcy Judge Lifland, and it further appearing that the cases hereinafter set forth should not be re-referred but should remain with the bankruptcy judges to whom they had been referred upon Stanley T. Lesser's resignation, evidenced by the initial set forth in parentheses following the captions of those cases,

NOW, it is

ORDERED, that all cases and petitions filed under the Bankruptcy Act, originally referred to Bankruptcy Judge Stanley T. Lesser, be and they hereby are re-referred to Bankruptcy Judge Burton R. Lifland, save for the following:
