Consolidation of Ownership Codes in NMMSS Historical Data is Complete


The staff of the NMMSS operator recently consolidated ownership codes in historic data into either code G or code J, DOE owned or privately owned, respectively. The consolidation was the last stage of a multiple stage effort that began last summer with the modification of the NMMSS to limit the use of codes G or J only in data generated October 1, 2003 and later. Modifying the historical data also included the addition of unique DOE project numbers in material moved from ownership codes A, B, or S into G.

Status of Facility Implementation of New NMMSS Forms

The user community has successfully transitioned to the new NMMSS forms that became effective October 1, 2003. Fewer than half a dozen facilities use the old forms, but these facilities do not submit significant quantities of data. Assistance is being provided to these facilities in the use of the new forms and the transition should be complete very soon.

Reporting of Americium Ingrowth by DOE Facilities

Shipments of plutonium to burial sites require the reporting of Americium ingrowth. Refer to DOE M 474.1-2A, Table XV-1. The word "burial site" is intended to mean place of final disposition of the material, e.g., WIPP, at which time the material leaves the NMMSS reporting requirements. In this connection, it is very important to bring the Americium on the books before or concurrent with reporting the shipment to WIPP as Americium ingrowth. Attention: All NRC and Agreement State Licensees – Bulletin Responses

As stated in previous newsletter updates, the Nuclear Regulatory Commission (NRC) issued Bulletin 2003-04 on October 8, 2003. This Bulletin was directed at NRC and Agreement State Licensee facilities that have active reporting identification symbols (RISs) and associated accounts in the Nuclear Materials Management and Safeguards System (NMMSS) database. The primary focus of the Bulletin is to request a reporting of the quantities of certain nuclear materials each licensee possesses. This reporting will allow NMMSS to review established book balances and work with the licensees to resolve potential discrepancies.

Bulletin responses were due January 6, 2004. NMMSS has reported to the NRC that some licensees have not yet responded. Licensees that have not responded should do so immediately. **Please note**: The NRC has stated that enforcement action may be considered for licensees who do not respond to the NRC requests associated with Bulletin 2003-04.
