#### **Note to Power Reactors**

In mid-January, each power reactor should have received a packet from NMMSS containing a letter from DOE and the U.S. Government's determination of your October 1, 2003 foreign obligated nuclear material balance. The DOE letter was prepared and provided to document that the initial balances are endorsed by the U.S. Government.

The NRC and DOE wish to clarify that the DOE letter does not mandate a response, but encourages a reply to the NMMSS operator by January 30, 2004. If a reply is not received by this date, the beginning balances provided in the January notification will be entered into the NMMSS. If you determine after January 30 that your beginning balance in NMMSS needs to be corrected, please coordinate with Ron Bonifay of the NMMSS. ## Reminder: NRC Bulletin Response is Due

The Nuclear Regulatory Commission (NRC) issued Bulletin 2003-04 on October 8, 2003. This Bulletin was issued so that the NRC could ascertain the actual location and quantities of nuclear material that licensees possess through a requested reporting of inventory holdings. Additionally, updating the Nuclear Materials Management and Safeguards System (NMMSS) national database will resolve database discrepancies and restore credibility to those account balances.

As of January 15, 2004, NMMSS had not received a reply from several facilities. The Bulletin requested a response from all facilities within 90 days, which ended January 6, 2004. NMMSS staff is providing regular status reports to the NRC concerning Bulletin response and resolution activities. Facility personnel that have not reported, as requested by the Bulletin, are urged to do so immediately.

#### NMMSS I Course Rescheduled

The NMMSS I course, (MCA-112) previously scheduled for January 26-29, 2004 has been rescheduled to April 13-16. This course was designed to help personnel who have fewer than two years' experience in materials accountancy. Prerequisites for the class are successful completion of a classroom or computer-based training version of two courses: Introduction to Nuclear Materials Control and Accountability (MCA-101D, -101DC) and Transaction Data Systems (MCA-103D or –103DC). The course is provided at the DOE NNSI facility in Albuquerque and there is no training fee for persons of a DOE facility or office. Other persons must pay a training fee.
