Foreign Obligations Material Balance Report

Have you heard about the NMMSS Report IA-OBL-05? This report keeps a running balance of each facility's foreign obligations, transaction by transaction, and can be useful in facility reconciliations. For those facilities that have foreign obligated material, the report shows the initial balance, any shipments or receipts, on-site gains and losses, and a total by material type and country of obligation. The report is based solely on the facility's transactions reported to NMMSS. It may be useful to review this information periodically to ensure that your facility's foreign obligations balances agree with those in NMMSS. This will expedite the reconciliation process for the foreign obligations material balances. If you would like to receive this report routinely (i.e. monthly, quarterly, or semi-annually), please contact a NMMSS analyst.

Initial NRC Licensee Training Course Successful

NMMSS training was provided to the NRC users community on October 18- 20, 2004, in Norcross. This was the initial course for NRC Licensees and based on the enthusiasm and participation of the 21 students in attendance, it appeared that the expectations were successfully met. Feedback was very positive, and in addition, some beneficial suggestions on how to enhance the presentations for future classes was received. The training concluded with the attendees receiving certificates acknowledging their successful completion of the course.

NRC NMMSS Training Course Scheduled for February 2005

The next NRC NMMSS training course will be conducted February 15-17, 2005 at the NAC Corporate Headquarters in Norcross, Georgia. This course is designed for individuals from NRC/Agreement State license holders with limited experience in NRC requirements related to nuclear material transfer and inventory reporting to NMMSS. The student will become familiar with NUREG/BR-0006 and NUREG/BR-0007. Additionally, the course will provide basic training in how to complete and submit nuclear material transaction forms (DOE/NRC Form-741), concise note forms (DOE/NRC Form-740M), Material Balance Reports (DOE/NRC Form-742), and Physical Inventory Listing reports (DOE/NRC Form -742C).



NMMSS On-Line RIS Updates

As a reminder, the NMMSS allows NRC and DOE facilities to electronically submit RIS updates via the NMMSS website. The website can be accessed at http://www.nmmss.com/onlinerisapp/ and provides detailed instructions on how to submit changes via the Internet.

When RIS changes are submitted to the NMMSS facility, NMMSS saves an electronic copy of the changes and immediately begins processing the information. Allowing facilities to submit changes this way reduces time spent on the phone verifying changes, ensures that NMMSS has the correct RIS

change information, and provides facilities the flexibility to submit changes when convenient.
