2005 NMMSS Users Annual Training Meeting

The 2005 NMMSS Users Annual Training Meeting will be held May 24-26 at the Ritz-Carlton, 921 Canal Street, New Orleans. The theme for this year's meeting is Building on the Foundation: Materials Accounting for the Future. The training meeting will focus on:

- Unified DOE/NRC reporting
- Reporting changes that will result from the NMMSS Upgrade
- Yucca Mountain reporting requirements
- Improving nuclear materials management in the post 9/11 environment

In addition, several presentations from NMMSS users will address lessons learned from challenges in reporting, from preparing for site closure to reporting foreign obligations.

Meeting Registration

Please note that providing NMMSS with the completed form will register you for the meeting but does not reserve your hotel room.

Making Reservations

Please make your hotel reservations directly with the Ritz-Carlton by calling 504-524-1331. To receive the special negotiated rate of \$146 per night (single or double), or \$166 (triple or quad), inform the reservation agent of your attendance at the NAC NMMSS Users Annual Meeting. Please note that the room rates are subject to state and local taxes,

currently 13% plus occupancy tax of \$2 per room per night. Reservations must be made with the hotel by May 2, after which time they will be released for sale to the general public. After May 2, the hotel agrees to make every effort to accommodate any late requests and reservations above the number of rooms blocked at the guaranteed rate. Should you decide to arrive in New Orleans early or remain following the meeting, we are pleased to announce that the special rate of \$146 or \$166 will be honored three days prior to and three days following the meeting, <u>based on guest room</u> <u>availability</u>.

2005 LANMAS Annual Users Group Training Meeting

The Local Area Nuclear Material Accountability Software (LANMAS) Annual Users Group Training Meeting will be held on May 23 from 9:00 a.m.-5:00 p.m., in the Acadia Room of the Ritz-Carlton. The meeting is scheduled in conjunction with the NMMSS Annual Users Training Meeting (May 24th-26th) to provide an opportunity for users to exchange information and obtain further clarification on NMMSS and LANMAS related activities. Discussions will focus on a status update of the LANMAS program, including user needs, software development, enhancements, ongoing installations, maintenance activities, and training. New Foreign Obligation Codes Added

Please make a note of the new foreign obligations code available for use in reporting to NMMSS. The new code was created for Chinese/Japanese obligated material. The new code is 86 for reporting transactional data on the DOE/NRC Form 741 and this material is reported on line 99 of DOE/NRC

Form 742, Part B. Current Tables of foreign obligations codes are updated regularly on <u>www.NMMSS.com</u>.

Establishing or Deactivating a RIS for NMMSS Reporting

DOE RIS:

In order for a new DOE RIS to be established in the NMMSS, the requesting organization must contact their field element or site office. The field office will provide the required information to DOE Headquarters, Office of Plutonium, Uranium and Special Materials Inventory, (SO-20.3). After SO-20.3 coordinates with the appropriate DOE Headquarters program offices and the Office of Financial Policy, they will instruct the NMMSS operator to assign the new RIS. The deactivation of the DOE RIS occurs when a facility's authorization to store/handle nuclear materials inventory is withdrawn. Before deactivation all inventory must be removed to a balance of zero. Notification of deactivation is sent from the field element or site office to SO-20.3. After SO-20.3 coordinates with the appropriate DOE Headquarters program offices and the Office of Financial Policy, they will instruct the NMMSS operator to deactivate the RIS. NRC RIS:

In order for a new NRC or Agreement State Licensee RIS to be established by NMMSS, the requesting organization must contact Patricia Tana at NRC Headquarters (301-415-8105) who in turn will instruct NMMSS to assign the new RIS. Before deactivation, all inventories must be removed to a balance of zero. Prior to deactivation, the NRC will request confirmation from NMMSS that the nuclear material balance is zero, and will subsequently instruct NMMSS to deactivate the RIS. March 2005 DOE Reconciliation and Database Closure


For the September 2004 reconciliation period, DOE facility nuclear material representatives and their staffs worked diligently with NMMSS staff to obtain a timely reconciliation and closure of the NMMSS September 2004 accounting periods. By October 15, 57 percent of the RISs, including those with the largest inventories and most transaction activities, were reconciled. By the end of October, 85 percent were reconciled, leaving only a few facilities to reconcile in November. The final RIS was reconciled and the NMMSS September 2004 books closed on November 12.

While this is a great improvement over previous reconciliation periods, it shows that there is still room for improvement. Therefore, NMMSS will be working with DOE facilities, oversight offices, and DOE Headquarters to reconcile all DOE facility March 2005 inventories in an even more expedited manner. All DOE facility inventories must be reconciled before the March 2005 NMMSS database can be closed. Therefore, NMMSS and the DOE facilities will be working to reconcile the inventories and close the March 2005 database by the end of April. Also, please be aware that DOE SO-20.3 will be monitoring the progress of the reconciliation and NMMSS will be providing them regular updates.


