

The meeting is for users to exchange information and obtain further clarification on LANMAS related activities and is scheduled in conjunction with the NMMSS Users Annual Training Meeting (May 22 to 24, 2007). Discussions will focus on a status update of the LANMAS program, including user needs, software development, enhancements, ongoing installations, maintenance activities, and training. ## **NRC Proposed Rule Published**

On February 6, 2007, the NRC published a proposed rule in the Federal Register. Some of the changes to NRC regulations being proposed involve reporting of nuclear materials to the Nuclear Materials Management and Safeguards System

(NMMSS). Following is a copy of the summary presented.

SUMMARY: The Nuclear Regulatory Commission (NRC) is proposing to amend its regulations related to licensee reporting requirements for source material and special nuclear material (SNM) to the **Nuclear Materials Management and Safeguards** System (NMMSS). The proposed amendments would lower the threshold of the quantities of SNM and certain source materials that require the submission of material status reports to the NMMSS. Also, the proposed amendments would make some modifications to the types of and timing of submittals of transaction reports to the NMMSS. The amendments would also require licensees to reconcile any material inventory discrepancies that NRC identifies in the NMMSS database. The proposed amendments would reduce some regulatory burden by reducing the current reporting requirements related to the export of certain source material and SNM. However. the annual reporting requirements would be new requirements for licensees who possess 350 grams or less, of SNM. These amendments are needed to improve the accuracy of the material inventory information maintained in the NMMSS.

The comment period on this proposed rule closes on April 23.



- Options for sending data to NMMSS electronically

### **SAMS 5.0**

In the November 2006 edition of the NMMSS Newsletter, it was incorrectly stated that SAMS 5.1 is the next release. Actually, SAMS 5.0 will be the next release of SAMS. The 5.0 release will include the following fixes and additions:

- Truncated values on the 741 form printout fixed
- Ability to print a simulated 749 form (Project Transfer)
- Ability to print a simulated 740 form (Concise Note)
- ◆ Ability to refresh the transaction, inventory or material balance lists in the SAMS 741, 742 and 742c Report Form screens after


- entering and saving data into SAMS
- ◆ Placement of the action date for a 'B' transaction on a 741 form
- Update of the User's Manual of SAMS to include instruction for the SAMS 741, 742 and 742c Report Form software
- ♦ Patch for the "I/O Operation" error
- Problem related to exporting duplicate inventory lines has been fixed
- Problem related to exporting a transaction with a weight percent isotope value of 100% has been fixed.

SAMS 5.0 will be released following successfully testing of the software. The testing is scheduled for completion by the end of February 2007.

SAMS is provided free of charge.

## **DOE Reporting of Total Volume**

NMMSS has recently implemented an edit check for the reporting of total volume on transactions. The implementation was made to reflect the actual requirement outlined in DOE Manual 470.4-6, Section B, Page IV-8. The Manual reads "The shipper must enter total volume, in cubic meters, if the transfer is to or from a DOE or NRC licensed waste management site, otherwise no entry is required." Therefore, NMMSS has implemented an edit check to verify that the total volume is reported on transactions involving a waste management site. This change makes the DOE requirement for reporting total volume the same as NRC. The NRC NUREG/BR-0006, Rev. 6 states "For transfers to or from nuclear waste sites (i.e., if the shipper or receiver RIS begins with the letter V), enter the volume of the material to be buried, stated in cubic feet rounded to the nearest cubic foot."



## **EURATOM Expansion**

Welcome Bulgaria and Romania to EURATOM!

Please make a note of the two new countries added to the European Atomic Energy Community (EURATOM). As of January 1, 2007, Bulgaria and Romania are included in EURATOM. The Community now has 27 member states: Austria, Belgium, Bulgaria, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Ireland, Italy, Hungary, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Poland, Portugal, Slovak Republic, Romania, Slovenia, Spain, Sweden, and the United Kingdom.

## NRC and Safeguards Information (SGI)

During the past few months, industry sent a number of questions to our NRC point of contact for NMMSS, Brian Horn, concerning data submission to NMMSS and whether such reports are "Safeguards Information" as defined by the NRC. Following is information that Brian Horn obtained from an NRC expert on "Safeguards information".

#### Dear Brian:

Thank you for bringing the issue of industry reporting information to the Nuclear Materials Management and Safeguards System (NMMSS) data base and whether the data of spent fuel movements is "Safeguards Information" as defined by the NRC. As you are aware, the NRC regulations are located at 10 CFR 73.21.

I have discussed your questions with my colleagues and we have prepared the following information which we hope answers the questions.

- Industry reports to NMMSS concerning movements of spent fuel from the reactor core to the spent fuel pool is not Safeguards Information.
- Industry reports to NMMSS concerning movements of spent fuel from the spent fuel


- pool to on-site dry storage location is not Safeguards information.
- Regarding industry reports to NMMSS concerning movements of spent fuel (from the pool or dry storage locations) to another site. If such a report to NMMSS is not submitted until the day after the spent fuel shipment, then the information is not Safeguards information. However, if the site submits the data to NMMSS any time earlier, then the NMMSS data is Safeguards Information.
- Industry reports to NMMSS summarizing the quantity of nuclear material at a reactor site (in the core, in the spent fuel pool, in dry storage, etc.) is not Safeguards information.


