#### **NMMSS Upgrade Status**

The Department of Energy (DOE), the Nuclear Regulatory Commission (NRC), NMMSS staff and Washington Savannah River Company staff participated in a meeting on August 21-22 to discuss the status of the NMMSS Upgrade. All parties agreed that the remaining project and implementation schedule should allow for the potential use of contingency. The team expects that during the summer of 2008, full parallel testing of the NMMSS Upgrade will occur. In addition, DOE and NRC jointly concurred with a proposed NRC revision of the effective date of NUREG/BR-0006 and NUREG/BR-0007 until January 1, 2009, to allow for potential contingency. The NRC representative informed the attendees that the NRC will seek to enact this revision.

# **2008 NMMSS Users Annual Training Meeting**



### SAMS 5.0 Bugs

The NMMSS is currently working on fixing the following bugs in SAMS 5.0. 1) The 80-column export option for Transactions puts '\*\*\*\*\*" as a value for Element Limit of Error in the export file regardless of what the true value is for that field.

2) Attempts to export Transaction data out to an XML-formatted file produce an application error.

3) The install instructions in the README file is missing a step (action) related to saving historical data. The user's guide contains all of the steps related to saving historical data.




