Plan to Attend the 2007 NMMSS Users Annual Training Meeting

The 2007 NMMSS Users Annual Training Meeting will be held May 22-24 at the Westin Peachtree Plaza, 210 Peachtree Street, in downtown Atlanta, Georgia. The training meeting's general sessions will focus on:

- ♦ Changes to NMMSS Reporting Under the NMMSS Upgrade
- Review of the Upgraded Safeguards Management Software (SAMS)
- Waste facility reporting
- ◆ Foreign Obligations What Do They Affect and Who Receives the Information
- ♦ Review of Electronic Reporting Methods
- Plans for the changes in NRC requirements for source material reporting
- ♦ Handling of Rounding and Decay

There will be breakout sessions for the DOE contractors and NRC licensees to discuss issues and topics of specific interest. The NRC session will cover such areas as NRC reconciliation and NUREG draft changes and upcoming rule changes. The DOE session will highlight DOE reconciliation, financial uses of NMMSS data, foreign obligations at DOE sites, and a DOE policy change update.

In addition to the general and breakout sessions, a training session on the current Safeguards Management Software (SAMS) will be conducted for new and experienced users.



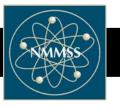
VISITING ATLANTA

The meeting is for users to exchange information and obtain further clarification on LANMAS related activities and is scheduled in conjunction with the NMMSS Users Annual Training Meeting (May 22 to 24, 2007). Discussions will focus on a status update of the LANMAS program, including user needs, software development, enhancements, ongoing installations, maintenance activities, and training. SAMS Training Scheduled in Conjunction with Users Meeting

An abbreviated Safeguards Management Software (SAMS) training will be held at the Westin Peachtree Plaza in Atlanta, Georgia on the afternoon of May 24. SAMS is a facility-based version of the Nuclear Materials Management & Safeguards System (NMMSS) software, managed by NAC International, for the U.S. Department of Energy (DOE) and the U.S. Nuclear Regulatory Commission (NRC). The SAMS software package provides the NMMSS user the ability to input data and perform edit checks at their facility for transactions, material balance reports, and inventories. The functionality of the system is similar to the NMMSS, enabling the user to resolve problems and make corrections prior to sending the data to NMMSS. The data can be exported to a text file to send to NMMSS via electronic media, direct link, encrypted email, or DOE's Secure Information Management Exchange (SIMEX).

The free training offered by NAC International will be of interest to those currently using SAMS, small facilities with few transaction activities, and larger facilities planning to automate their system and integrate SAMS. This seminar will cover versions currently being used to report to NMMSS. In early 2008, a training session will be offered covering the use of the SAMS version to be used once the NMMSS Upgrade is implemented.



New NRC Edit Check

Historically, NMMSS has accepted nuclear material transactions from NRC licensees for any material type and owner code that is tracked by the NMMSS. Many of the nuclear material transactions involved

materials that the NRC does not require to be reported to NMMSS. Over the past couple of years, the NRC has directed NMMSS to work with NRC licensees to remove balances of materials in the NMMSS data base that is not required by NRC regulations to be in NMMSS. NRC and DOE have recently agreed that actions shall be taken to ensure that balances of materials that are not required by the NRC to be in NMMSS are not reintroduced into the NMMSS data base. In response to a joint DOE and NRC directive, the NMMSS operator has developed an NMMSS edit check that will flag as an error any NRC licensee submission of material that is not required to be reported to NMMSS. This NMMSS edit should impact few, if any, licensees. Following is some additional information on this edit check.

- ◆ Transactions for receipt, shipment, or on-site adjustment (A-M transaction) of "Jownership" (Not U.S. Government owned) materials types for Am-241, Am-243, californium, curium, deuterium, enriched lithium, neptunium, and tritium will be flagged as an error and not accepted into NMMSS.
- ◆ Transactions for the receipt, shipment, or onsite adjustment of "J-ownership" (Not U.S. Government owned) materials types for depleted uranium, natural uranium, enriched uranium, uranium in cascades, U-233, thorium, plutonium, and Pu-238 will be accepted into NMMSS.
- ◆ Transactions for the receipt, shipment, or onsite adjustment of "G-ownership" (U.S. Government owned) materials types for Am-241, Am-243, californium, curium, deuterium, enriched lithium, neptunium, tritium, depleted uranium, natural uranium, enriched uranium, uranium in cascades, U-233, thorium, plutonium, Pu-238, and Pu-242 will be accepted into NMMSS.
- Transactions documenting a change in ownership for all material types will be accepted into NMMSS.

The above is meant to provide a general description of the new edit check. For assistance with specific situations, please contact a NMMSS analyst. Also, additional guidance for reporting "G-ownership" material is located in DOE Manual 470.4-6.

This NMMSS edit check will become effective June 1, 2007 and is expected to have minimal impact on the licensee community.

Dates Finalized for Upcoming NMMSS Training Course for NRC Licensees

The next licensee NMMSS-1 training course is scheduled for April 24-26, 2007 in Atlanta, Georgia. The course will include the following topics among others:

- Completion of data input forms: transaction, material balance, inventory, and concise notes
- Demonstration of the use of SAMS in creating electronic data submissions
- Options for sending data to NMMSS electronically


Establishing or Deactivating a RIS for NMMSS Reporting

DOE RIS

In order for a new DOE RIS to be established in the NMMSS, the requesting organization must contact their field element or site office. The field office will provide the required information to DOE Headquarters, Office of Information Management, (HS-1.22). HS-1.22 will instruct the NMMSS operator to assign the new RIS. The deactivation of the DOE RIS occurs when a facility's authorization to store/handle nuclear materials inventory is withdrawn. Before deactivation all inventory must be removed to a balance of zero. Request for NMMSS deactivation of the RIS is sent from the field element or site office to HS-1.22. HS-1.22 will confirm with the NMMSS that the nuclear material balance is zero and will instruct the NMMSS operator to deactivate the RIS. NRC RIS

In order for a new NRC or Agreement State Licensee RIS to be established by NMMSS, the requesting organization must contact Brian Horn at NRC Headquarters (301-415-8128) who in turn will instruct NMMSS to assign the new RIS. Before deactivation, all inventories must be removed to a balance of zero. A request for the deactivation of a NRC issued RIS must also be directed to Brian Horn at the NRC (301-415-8128). Prior to

deactivation, the NRC will request confirmation from NMMSS that the nuclear material balance is zero, and will subsequently instruct NMMSS to deactivate the RIS. For additional guidance on establishing a new NRC RIS, contact Ron Bonifay at rbonifay@nacintl.com or 678-328-1116.

Meet the Staff


