NMMSS TRANSITION FROM NORCROSS, GEORGIA

Effective September 26, 2008 NMMSS operations will have officially been transitioned from NAC International in Norcross, Georgia to the Office of Health, Safety and Security (HSS), DOE, Germantown, Maryland. DOE Savannah River, the NMMSS upgrade developer and the continuity of operations backup site, will help HSS with the transition and play a vital role in providing the current level of support to both DOE and NRC stakeholders.

- ◆ The NMMSS database will be unavailable to operate or process facility submissions starting at 5 pm, Eastern Time September 25, 2008.
- ◆ Normal operations of the NMMSS database are expected to resume on or before October 13, 2008.
- ◆ We will issue a Special Edition of the NMMSS Newsletter to notify the NMMSS user community when full operations of the NMMSS database resumes.
- ◆ During this period, both the DOE and NRC sites will be expected to continue to submit data to NMMSS.
- ◆ Between 5pm September 25 and restart of the NMMSS database, on or before October 13, the NMMSS database will be unable to accept data on either the classified or unclassified direct link. If your site plans to submit data by the direct link during this time period, you will have to either provide your information by other approved communication methods, or hold your submittals until the direct link is re-established.

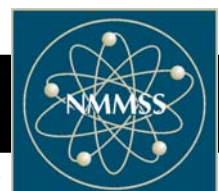
