Bankruptcy Filings Up for Calendar Year Total for Year Misses Historic High

Bankruptcy filings in the federal courts remained high in calendar year 2003, according to data released today by the Administrative Office of the U.S. Courts. Total bankruptcies filed in the twelve-month period ending December 31, 2003, totaled 1,660,245, up 5.2 percent from the 1,577,651 bankruptcies filed in the 12-month period ending December 31, 2002. The calendar year total for 2003, however, did not break the historic high for a 12-month period, which was reported in fiscal year 2003 at 1,661,996. The Judiciary's fiscal year ends September 30.

The majority of bankruptcy filings are non-business filings and in calendar year 2003, they numbered 1,625,208. In calendar year 2002, they totaled 1,539,111. The number of business filings continued to decline, totaling 35,037 in 2003. They totaled 38,540 in 2002.

The last three months of calendar year 2003 were the first quarter of the Judiciary's 2004 fiscal year. The number of bankruptcies filed during the first quarter of fiscal year 2004 (October 1-December 31, 2003) was 393,348. That is down 0.5 percent from the 395,129 filings for the first quarter of fiscal year 2003 (October 1-December 31, 2002).

New Bankruptcy Judgeships Requested

As the number of bankruptcies filed in federal court has increased, the number of filings per judgeship also has grown. In calendar year 1993, filings per judgeship totaled 2,685. By 2003, filings per judgeship had increased 90.8 percent to 5,124.

Despite the continued increase in bankruptcy filings, no new bankruptcy judgeships have been created since 1992. Legislation that would authorize 36 new bankruptcy judgeships, H.R. 1428, was introduced in the first session of the 108th Congress and is pending in the House. S. 878, which was passed by the Senate in the first session, would create 36 bankruptcy judgeships, in addition to new Article III judgeships. The Senate bill was referred to the House Judiciary Subcommittee on the Courts for consideration.

Filings by Chapter

Of the total number of bankruptcy filings for the 12-month period ending December 31, 2003, there were 1,176,905 Chapter 7 filings, up 6.0 percent from the 1,109,923 Chapter 7 filings in the same period in

2002. The next largest group of filings was Chapter 13 filings at 473,137, up 3.8 percent from the 455,877 filings in calendar year 2002. Chapter 11 filings fell 16.6 percent to 9,404, from the 11,270 filings in calendar year 2002. In 2003, Chapter 12 filings rose 46.8 percent to 712, from 485 in 2002. A similar surge in filings was reported for fiscal year 2003 and mostly likely can be traced to the retroactive extension of provisions for filing under this chapter, which has occurred several times since provisions for filing under Chapter 12 first expired in 2000.

Chapter 7 is designed to allow individuals to keep certain exempt property while the remaining property is sold to repay creditors. Under Chapter 13 bankruptcy, creditors may be repaid in installments, in full or in part, over a 3- to 5-year period. Chapter 11 provides for a business to continue operations while formulating a plan to repay its creditors. Chapter 12 is designed to meet the needs of financially distressed family farmers. Chapter 9 provides protection for a financially distressed municipality from its creditors while it develops and negotiates a plan for adjusting its debt.
