SUBJECT: SUMMARY OF THE SEPTEMBER 18, 2002, PUBLIC MEETING TO DISCUSS FIRSTENERGY'S CORRECTIVE ACTION PLAN FOR MANAGEMENT AND HUMAN PERFORMANCE IMPROVEMENT

On September 18, 2002, the Nuclear Regulatory Commission (NRC) held a public meeting at the Davis-Besse Nuclear Power Station Energy Education Center in Oak Harbor, Ohio. The meeting was between the NRC Davis-Besse Oversight Panel and FirstEnergy Nuclear Operating Company (FENOC) to discuss the licensee's planned corrective actions to address the Davis-Besse organizational and human performance problems presented to the the NRC during the August 15, 2002, public meeting.
