	The Department of Defense (DoD) obligated \$79.4M during the week ending May 1, 2009 bringing the cumulative obligations of Recovery Act funds to \$188.8M. The \$188.8M in obligations are over 2.5% of all DoD Recovery Act Funds received and reflect over 230 contracts to non-Federal vendors. Of the contracts awarded, over 90% of the dollars were awarded to small businesses of which over 20% were to Hispanic owned small businesses.	The Department will submit draft guidance on execution of the Homeowners Assistance Program to the Office of Management and Budget for review.			
	Army obligated \$32.0M this week for its first Recovery Act Military Construction project. This is for the first phase of a Warrior in Transition complex at Fort Bliss, TX. The next phase of the project will be awarded this summer.	The Army plans to award an Army National Guard construction project for Storm Sewers at Camp Withycombe, OR on or about May, 9, 2009 for \$1.2M.			
	The Department of the Navy obligated \$6.7M this week for a cumulative obligation total of \$43.2M, 3.5% of the total ARRA funding for Navy. Contracts awarded include: one military construction project for Facility and Photovoltaic Upgrades at Camp Lejeune, NC for \$1.2M and three Facilities Sustainment, Restoration and Modernization (FSRM) projects.				
	The Air Force obligated \$40.8M this week for a cumulative obligation total of \$112.1M. Contracts awarded this week included \$44.5M in FSRM contracts offset by a correction of an erroneous obligation of \$3.8M to the Air National Guard, Operations and Maintenance Appropriation. The FSRM contracts awarded this week include, but are not limited to, \$3.7M for repairing perimeter fences at Lackland AFB, TX; \$3.5M for repairs and storm drainage on all the contracts awarded this week include, but are not limited to, \$3.7M for repairing perimeter fences at Lackland AFB, TX; \$3.5M for repairs and storm drainage on all the contract and the contract are not limited to the contract and the contract are not limited to, \$4.5 and other minor projects at multiple facilities.				
	The Department released the remaining list of Army facility repair projects (\$835M for 856 projects) to Congress on April 28, 2009. These new projects are in addition to the Deparment's first ARRA infrastructure investment list submitted to Congress on March 20, 2009.
