The subsequent document includes new features/functionality, known software issues/limitations, and frequently asked questions (FAQs) for DTrade 2. Please refer to this document prior to reporting any new defects.

1.0 Known Bugs

This list covers the known issues with DTrade2 version 2 PureEdge and Batch.

BUG ID: DT2- ADD -00001 – License Value Displayed on External Track Status results screen

Related to PR-DT-20090505-2351.

The user display of the License Value on the external Track Status results screen may differ from that which was submitted (the actual License Value has been truncated). This is a display issue, and does not affect the content of the submission or the license.

Solution:

No work-around is necessary. Code will be changed in the future to display complete value.

BUG ID: DT2-ADD-00002– List of Amendment Types on signed DSP-6 and DSP-74 PDF licenses.

Related to PR-DT-20090513-2364.

Despite the actual amendment type(s) submitted by the user, the complete list of amendment options is erroneously displayed on the signed PDF licenses for DSP-6 and DSP-74 forms.

Solution:

No work-around is necessary. The user can ignore the list of amendment types provided in Block 8 of the signed license provided that the individual block information is displayed correctly, Code will be changed in the future to display only selected values.

BUG ID: DT2- ADD -00003 – Applicant’s Statement mistranslated for Batch amendment (DSP-6, DSP-62, and DSP-74) submissions.

Related to PR-DT-20090513-2369.

The Applicant’s Statement (XML element ApplicantStatementCertification) may be displayed internally different than submitted by the user.

Workaround:

To ensure that the intended Applicant Statement selection is identified, the user should include text in the Additional Details of Transaction block outlining which Applicant Statement was selected.

DSP6: Additional Details of Transaction (PureEdge Block 21, XML element AdditionalDetails)
DSP62: Additional Details of Transaction (PureEdge Block 22, XML element AdditionalDetails)
DSP74: Additional Details of Transaction (PureEdge Block 21, XML element AdditionalDetails)

The following text should be used:

For statement a (AuthEligible):

This submission indicates an Applicant's Statement selection of "a."

For statement b (AuthNotEligible):

This submission indicates an Applicant's Statement selection of "b." We have submitted a 22 CFR § 126.13 Certification Letter and a 22 CFR § 127.11 Exception to Policy Letter in accordance with this selection.

For statement c (AuthNotEligibleException):

This submission indicates an Applicant's Statement selection of "c." We have submitted a 22 CFR § 126.13 Certification Letter in accordance with this selection.

For statement d (NotAuthEligible):

This submission indicates an Applicant's Statement selection of "d." We have submitted a 22 CFR § 126.13 Certification Letter in accordance with this selection.

For statement e (NotAuthNotEligible):

This submission indicates an Applicant's Statement selection of "e." We have submitted a 22 CFR § 126.13 Certification Letter and a 22 CFR § 127.11 Exception to Policy Letter in accordance with this selection.

For statement f (NotAuthNotEligibleException):

This submission indicates an Applicant's Statement selection of "f." We have submitted a 22 CFR § 126.13 Certification Letter in accordance with this selection.
