# EXTEND A TEACHING INTERN CERTIFICATE

## ARIZONA DEPARTMENT OF EDUCATION – CERTIFICATION UNIT

The Teaching Intern Certificate is valid for 1 year and may be extended yearly for no more than two consecutive years. The Teaching Intern Certificate entitles the holder to enter into a teaching contract while completing the requirements for an Arizona Provisional teaching certificate. The candidate shall be enrolled in an Arizona State Board authorized alternative path to certification program, or an Arizona State Board approved teacher preparation program. This certificate is valid only in the Arizona district or charter school that requests the certificate and is not transferable. An individual is not eligible to hold the certificate more than once in a five-year period. In addition, an individual that receives an intern certificate and does not complete the requirements for a Provisional certificate shall not be eligible for an emergency teaching certificate.
