

The stakeholder information in the *Directory* is intended to supplement the lists of potentially affected or interested parties that Department of Energy (DOE) Offices compile for particular projects or facilities.

The body of the *Directory* lists contacts in Federal agencies, states, and nongovernmental organizations. A new feature of the 2009 *Directory* is the restructuring of the Federal agencies section to list cabinet level departments first, followed by other Federal agencies. In addition, to ensure up-to-date information, the state contacts section (page 18) now refers to the listing on the National Governors Association website (www.nga.org) instead of listing state governors by name. The *Directory* indicates each contact's preferences for receiving NEPA documents as paper copies, compact disks, or notification of a Web address where the document is posted.

This *Directory* complements the June 2006 guidance on *EIS Distribution* (www.gc.energy.gov/NEPA/documents/eis_distribution_guidance.pdf). The appendices list DOE contacts (NEPA Compliance Officers, Public Affairs Directors at DOE Offices and National Laboratories, and contacts for tribal issues) and public reading rooms where DOE Program and Field Offices typically make NEPA documents available for review.

PREFACE

This *Directory of Potential Stakeholders for DOE Actions under NEPA* is prepared by the Office of NEPA Policy and Compliance.



The *Directory* is available on the DOE NEPA website at <http://www.gc.energy.gov/NEPA/documents/StakeholdersDirectory.pdf> from which selected contact information can be copied into other applications to produce mailing lists, letters, or labels. It complements the *EIS Distribution Guidance* (http://www.gc.energy.gov/NEPA/documents/eis_distribution_guidance.pdf), issued by the Office in June 2006.

The Council on Environmental Quality regulations implementing NEPA include provisions for public involvement:

- Agencies must ensure that environmental information is available to public officials and citizens before decisions are made and before actions are taken [40 CFR 1500.1(b)].
- Agencies must involve environmental agencies, applicants, and the public, to the extent practicable, in preparing environmental assessments and must affirmatively solicit comments on draft environmental impact statements from those persons or organizations who may be interested or affected [40 CFR 1501.4(b) and 1503.1(a)(4)].
- Agencies must also provide public notice of NEPA-related hearings, public meetings, and the availability of environmental documents so as to inform those persons and agencies who may be interested or affected and must solicit appropriate information from the public [40 CFR 1506.6(b) and (d)].

To assist Departmental Program and Field Offices in complying with these requirements, the *Directory* lists contacts in Federal agencies, states, and nongovernmental organizations. For the convenience of users, the appendices list DOE contacts: NEPA Compliance Officers, public affairs directors at DOE Offices and National Laboratories, contacts for tribal issues, and DOE public reading rooms and libraries. All persons in the *Directory*, including those listed in Appendices A through C, are listed in the index.

DOE Offices should exercise judgment in determining which of the listed contacts may be interested in a particular proposed action. Listing in this *Directory* is not meant to imply that the person or organization should receive every DOE NEPA document. Rather, the information provided is meant to supplement lists that Departmental Offices compile for individual projects or facilities.

To allow the Department to better accommodate potential stakeholders, the *Directory* indicates their preferences for receiving DOE NEPA documents (i.e., number of compact disks  or paper copies ) or notification of a web address where the document is posted.
