Department of Human Services to host public meetings this fall

Agency seeks input from stakeholders for program planning and budgeting

BISMARCK, N.D. – The North Dakota Department of Human Services is hosting public meetings across the state this fall and invites clients, service providers, advocates, county and Tribal officials, legislators, and other stakeholders to attend. Agency officials are seeking input on community needs and successes in serving vulnerable individuals. Meetings were held in Grand Forks and Devils Lake last week, and have been scheduled in Bismarck, Dickinson, Fargo, Jamestown, Minot, and Williston in October.

"We hope to identify broad areas of interest and to seek ideas and recommendations from our partners in North Dakota's human services system," said Department Executive Director Carol K. Olson. "These public meetings are a vital part of the planning that shapes how services are provided, and they also factor into preliminary work on the department's 2009-2011 budget request."

The department administers child protection services, child support enforcement, disability services, food stamps, foster care, economic assistance programs, Medicaid, the children's health insurance program, home and community-based long term care services, mental health and substance abuse treatment services, and aging services including senior meals and related services. The department also includes the Developmental Center, the State Hospital, and the eight regional human service centers, which provide mental health and substance abuse treatment at the local level.

Together, the department, counties, Tribes, and other public and private organizations deliver human services in North Dakota.
