ILLP – Guidance Document

- Authority "Schools with 20 or fewer ELLs within a three grade span..."
- Background ILLP language was included in the SEI Models to address special circumstances of schools with a low incidence of ELLs

ILLP – Guidance Document

Provisions

- Mixing of ELLs with non-ELLs in mainstream classrooms
- four hours of ELD
- two hours of ELD as prescribed in Language Star
- ELP Standards with DSI focus in lesson
- Ianguage driven ILLP
- teacher collaboration in writing and implementing of ILLP
- formative assessment documentation required
- mainstream teacher utilizes strategies appropriate for working with English language learners.

Guidelines for Implementation

Elementary School K-6

- mainstream classroom teacher will document ILLP requirements
- two hours of ELD
- one hour reading block
- one hour writing block

Guidelines for Implementation

Middle School / High School

- Language Arts / English teacher will write and oversee implementation of ILLP
- inclusion of five parts of the language star

Options for ILLP implementation

Option 1 – Four periods of English daily

- highly recommended for Pre-Emergent and Emergent ELLs
- Option 2 Three periods of English daily with the fourth period of ELD delivered in elective or required content class
 - highly recommended for Basic level ELLs
- Option 3 Two periods of English daily option with the third and fourth periods of ELD delivered in elective and/or required content classes
 - highly recommended for Intermediate level ELLs

Language Proficiency Recommendations for ELLs on ILLPs

It is highly recommended that:

- English language learners who are at the Pre-emergent or Emergent level of English proficiency receive the four periods of English daily option (Option 1)
- English language learners who are at the Basic level of English proficiency receive three periods of English daily option (Option 2)
- English language learners who are the Intermediate level of English proficiency receive two periods of English daily option (Option 3)

- English Language Development Strategies in Science
- English Language Development Strategies in Social Studies
- English Language Development Strategies in Math
