Gov. Blagojevich announces free tax preparation counseling and services for low-income families

Officials urge Illinois workers to apply for the expanded Earned Income Tax Credit (EITC) and new homeownership opportunities

CHICAGO – Governor Rod R. Blagojevich today encouraged working families to use free tax counseling services to maximize their tax refunds and apply for the recently expanded Illinois Earned Income Tax Credit (EITC). This year’s tax counseling plan marks the first time that low income families are encouraged to connect tax refunds and credits to matched savings accounts for homeownership. Illinois Department of Human Services (IDHS) Secretary Carol L. Adams, PhD., and Illinois Department of Revenue (IDOR) Director Brian Hamer today joined with the Center for Economic Progress and the Tax Assistance Program to announce the innovative plan and urged more people to take advantage of free tax preparation services, and the newly expanded Illinois EITC. This year, Governor Blagojevich signed legislation which made 100,000 more Illinoisans eligible for the Illinois EITC.

“Our goal is simple. We want to help families apply for the Earned Income Tax Credit and use their tax returns to help buy a new home.” said Gov. Blagojevich “We are offering low-income families the tax counseling and opportunity to take the cash from their tax to pursue the dream of homeownership.”

At the tax counseling sites, families throughout the state of Illinois will be invited to participate in the Asset\$Illinois Homeownership Initiative, which provides a \$1 for \$1 match on savings up to \$2000 towards the purchase of a first home. Other families will be offered access to student financial aid along with tax counseling services, a benefit that can yield more than \$10,000 in federal and state student assistance. IDHS hopes to provide more than 1000 Illinois families with access to both of these programs this tax season.

As workers prepare to file their income returns, Illinois Department of Revenue Director Brian Hamer is reminding workers to see if they qualify for the Earned Income Tax Credit (EITC), which can help boost their take-home pay, and to take advantage of newly-expanded tax preparation services being offered for free through the state.

Governor Rod R. Blagojevich signed legislation in August expanding eligibility for the Illinois EITC refund to an additional 100,000 hard-working Illinoisans. The new law ended the provision that required individuals to qualify for federal Temporary Assistance for Needy Families (TANF) money in order to receive an Illinois EITC refund.

"Every dollar counts when you are living on a modest income; that's why the free tax counseling and assistance programs are so important to families," Director Hamer said. "This year we are encouraging taxpayers to avoid high interest refund anticipation loans which can siphon off a large portion of their refund. Taxpayers should file electronically either at home or with a tax professional in order to get their Illinois tax refund in about a week."

The Earned Income Tax Credit, the major federal benefit for low and moderate-income families, can be worth as much as \$4,716 to a family with two or more children. In addition, the state EITC can provide up to \$235 in state income tax relief. Together, these benefits put money back into the pockets of Illinois' working families.

Secretary Adams said IDHS is reaching out to the people it serves, as well as those who have left IDHS programs for jobs. IDHS is encouraging these individuals to take advantage of the Earned Income Tax Credit (EITC) and free tax counseling provided by the Tax Counseling Project and the Tax Assistance Program. Most sites will open on January 26 and provide services through April 12.

IDHS provides funding to the Tax Assistance Program and the Tax Counseling Project, which is administered by the Center for Economic Progress. This year the state will support free tax counseling at 64 locations across the state, the most ever. These programs offer free tax assistance and promote the EITC to low-income workers. The services are provided free of charge to families with incomes less than \$40,000 and to individuals with incomes under \$15,000. Last year, nearly 30,000 Illinoisans received free income tax preparation assistance worth \$43 million in refunds.

"The tax refund is the largest single payment of any kind that working families receive all year. And with the right help, families can use the tax refund as a stepping stone from falling behind to getting ahead," said David Marzahl, Executive Director of the Center for Economic Progress. "For more than a decade, the Center for Economic Progress has helped 175,000 low-income families get the max from tax time. We offer free tax help in 40 communities throughout Illinois. We make sure families claim all the benefits and credits they are entitled to and we have financial coaches at our tax sites to teach families how to use that refund wisely."

Low-income working families, many of whom may be new to the workforce, often do not have access to affordable, professional tax preparation. Many taxpayers use tax preparation services that charge high fees. Some are also persuaded to apply for “rapid refund” loans with high interest rates and fees which can greatly reduce their actual benefits.

“For many households, these benefits are critical to rising out of poverty and making the transition from dependency to lasting self-sufficiency,” Secretary Adams said. “We are continuing to make as many Illinois workers as possible aware of the EITC and how to apply for it. Additionally, the EITC does not affect eligibility for IDHS benefits.”

The Tax Counseling Project trains volunteers to provide free tax services to families and individuals at 15 locations in Chicago and 19 other sites throughout Illinois. DHS also funds the Tax Assistance Program (TAP), which has 25 locations in Chicago and the suburbs. TAP recruits tax professionals to volunteer to assist low-income families.

Volunteers will prepare federal and state returns for the current year and, if necessary, for the past tax years. Volunteers also provide counseling and advise workers about withholding allowances, filing status, and other tax benefits (such as the Child Credit and the Child Care Credit) for which they may qualify.
