The plan was prepared in response to language in Senate Report 106-395 accompanying the Fiscal Year 2001 Energy and Water Development Appropriations Bill, which directed that an interagency working group be created in order to increase international market opportunities for the export and deployment of advanced clean energy technologies. The Department of Energy, on behalf of the Clean Energy Technology Exports Working Group (see below), has prepared this Strategic Plan.

In accordance with the report language, four main activities were initiated:

- The formation of a Clean Energy Technology Exports Working Group (CETEWG). The co-chairs of this working group are the Department of Energy, the Department of Commerce, and the United States Agency for International Development. Other participating agencies include the Department of State, the Department of the Treasury, the Environmental Protection Agency, the Export-Import Bank, the Overseas Private Investment Corporation, and the Trade and Development Agency.
