Current Projects – 2005-2006

County EUDL Awards

In an effort to prioritize underage drinking efforts across the state, DHS has allocated funds in each county, on a per capita basis, to provide a variety of underage drinking prevention activities. Each county and tribe has submitted a plan to utilize these funds specifically for underage drinking prevention in the following areas: Facilitation of Community Partnerships (coalition building); Minor Decoy Operations; Controlled Party Dispersal Operations; Shoulder Tap (stranger purchase) Operations; Reward and Reminder Programs; and Strategic Media Advocacy.

Statewide Public Education Effort

The Oregon Partnership has been selected as our statewide public education contractor. Through these funds, the contractor will develop and implement a comprehensive statewide public education effort utilizing multiple forms of media, including television, radio, print, and internet messages. The primary intent is to deliver multi-faceted messages about the dangers and costs associated with underage drinking and the laws regarding furnishing alcohol to minors. Parents will be the main focus of the messages, which will also target appropriate cultural and ethnic populations throughout the state.

The OSU/UO Project focuses on promoting underage drinking prevention messages at OSU and UO football and basketball games utilizing their far reaching radio broadcast networks. Underage drinking prevention messages are being broadcast during each of the schools' football and basketball games through the 2005-06 seasons. The Coos County Task Force is focusing its efforts on minor decoy and controlled party dispersal operations. The Clatsop County EUDL Project is working to provide consistent responses to underage drinking parties through the training of a coalition of law enforcement agencies, strategic media advocacy, combined training for all enforcement agencies on controlled party dispersal techniques, and increased communication among law enforcement. The Safe Communities Underage Drinking Project is working closely with their community coalition to develop baseline numbers on attitudes and practices of community members. This information will be used to plan and implement a coordinated effort for educating adults on the dangers and costs of underage drinking through community presentations, training, and media advocacy. In addition, the project is funding a controlled party dispersal team that includes local, county and state police officers, and the Oregon Liquor Control Commission.

The CERV Task Force has been active for a number of years, and continues to provide increased enforcement of laws dealing with alcohol sales to minors through minor decoy operations, ID checks at local bars and taverns and the development of a memorandum of understanding among jurisdictions for those situations which involve cross-jurisdictional boundaries. In addition, the Task Force provides Alcohol Enforcement Specialist Training for local law enforcement agencies, campus safety officers, and Willamette University Residence Life Advisors on minor decoy and controlled party dispersal. The Task Force has also begun utilizing alcohol vendor mapping in the major cities of the county to track where alcohol is sold, and to promote the OLCC Responsible Vendor Program.

The Rout 99E project focuses on a multi-lingual underage drinking public information and education effort. Included in the project is a public service announcement activity which translates/modifies existing DUII messages and distributes those through local Hispanic radio stations. The Lincoln County Project is strengthening policies and procedures between local law enforcement agencies and the judicial system to improve the efficiency of underage drinking enforcement activities. This includes increase minor in possession law enforcement, as well as holding offenders accountable through standardized procedures, zero tolerance among law enforcement, and strong ties with the county's Teen Court. In addition, compliance checks and public and retailer education activities have been increased to raise awareness of underage drinking issues.

This media focused project provided public service announcements aimed primarily at adults' furnishing alcohol to minors, parental responsibilities and other underage drinking messages, and had those youth-produced messages placed on radio stations across the state. One message, utilizing the voice of Oregon's First Lady, Mary Oberst, was also translated by Ms. Oberst and ran on Hispanic radio stations across the state. More than \$100,000 was donated through in-kind running of the media PSA's.
