THE NUMBERS YOU SEE ON THE CHART ARE FOR THE FIRST HALF OF FISCAL YEAR 09 COMPARED TO 08.

AS PART OF TODAY'S PRESENTATION, WE'RE GOING TO TALK ABOUT SOME RECENT ACTIVITY ON THE SYSTEM AS A RESULT OF THE RECOVERY ACT.

THE BOTTOM LINE IS AS YOU CAN SEE BY THESE NUMBERS ARE VOLUME HAS INCREASED ACROSS THE BOARD.

SO FOR SUBMISSIONS, YOU CAN SEE OVER FIRST HALF OF LAST YEAR, SUBMISSIONS ARE UP 20%.

SPECIFICALLY IN THE MONTH OF MARCH, WE PROCESSED 38,646 SUBMISSIONS WHICH IS A 143% INCREASE OVER THE SUBMISSIONS PROCESSED IN JANUARY, WHICH WAS 15,931.

THE AOR S , AUTHORIZED ORGANIZATION REPRESENTATIVES, THOSE ARE THE INDIVIDUALS THAT CAN SUBMIT GRANTS ON BEHALF OF THE ORGANIZATION.

YOU CAN SEE THOSE TOTALS ARE UP 43%.

A POINT HERE IS FOR YOU E BUSINESS POINT OF CONTACT PERSONNEL OUT THERE, COUP IN MIND, YOU CAN MAINTAIN THE AOR S , SO IF AN AOR LEAVES THE ORGANIZATION YOU CAN DELETE THEM.

THE VOLUME ON THE CONTEXT THERE IS UP 27%.

IN MARCH ALONE WE ANSWERED 34,536 CONTACTS.  
THAT'S CALLS AND E-MAILS.

THAT IS A 182% INCREASE OVER THE CONTACTS WE ANSWERED IN DECEMBER WHICH WERE 12,259.

SO WHAT WE'VE DONE, IF YOU EXPERIENCED IN THE BEGINNING OF MARCH OR FEBRUARY, IF YOU CONTACTED THE CONTACT CENTER AND EXPERIENCED A LONG WAIT TIME FOR MAYBE A BUSY TONE, WHAT WE'VE DONE IS TODAY WE HAVE 77 CUSTOMER SUPPORT REPRESENTATIVES WHO ARE TRAINED TO ANSWER CALLS AND E-MAILS.

WE HAVE A NEW HIGHER CLASS WHICH IS FINALIZED, FINISHING UP AS WE SPEAK TODAY WHO WILL BE ON THE PHONES ON APRIL 20 WHICH IS MONDAY.

THAT'S AN ADDITIONAL 22 CSR'S, CUSTOMER SUPPORT REPS.

STARTING ON MONDAY, APRIL 20, WE WILL HAVE 99 CUSTOMER SUPPORT REPS TRAINED TO ANSWER GRANTS.GOV CALLS.

AND E-MAILS.

NEXT MAY 10 WE'RE HAVING ANOTHER CLASS TARGETED RIGHT NOW FOR 10 PEOPLE.

ALSO AS I MENTIONED IF YOU DID EXPERIENCE A BUSY TONE, ORIGINALLY WE HAD WHAT'S CALLED 5T1 PHONE LINES THAT COULD ANSWER 120 SIMULTANEOUS CALLS.

WE HAVE INCREASED THAT UP TO 9T1 PHONE LINES.

WE CAN NOW TAKE 216 SIMULTANEOUS CALLS.

SO ON THE VOLUME, ON THE NEXT CHART, THE WEBSITE HITS ITSELF, THE SESSIONS, THE NUMBER OF PEOPLE CLICK ON THE SITE.

YOU CAN SEE THE INCREASES THERE.

IN MARCH WE HAD 1.9 MILLION HITS ON THE SITE COMPARED TO THE 815,000 IN DECEMBER OF '08.

THAT IS A 145% INCREASE.

THE NEXT CHART SHOWS THE PAGE VIEWS.

SO WHEN SOMEBODY COMES TO THE SITE, THIS IS THE NUMBER OF PAGES THEY VISIT.

IN MARCH, 5.5 MILLION PAGE VIEWS.

WHICH IS A 138% INCREASE OVER THE DECEMBER PAGE VIEWS OF 2.3 MILLION.

SO THE REASON WE'RE POINTING THESE OUT, AS A RESULT OF THE RECOVERY ACT, THERE IS A LOT OF VOLUME, A LOT OF INTEREST ON THE SITE.

SO NEXT, ONE OF THE THINGS WE HAVE DONE, WE HAVE TALKED ABOUT ON SEVERAL OF THE WEBCASTS IS THE TRANSITION TO ADOBE.

AS MANY OF YOU ARE AWARE WE WERE TRANSITIONING FROM YOUR PERCENTAGE BASED FORMS TO ADOBE BASED FORMS WORKING WITH THE AGENCIES ON THAT MIGRATION, THAT TRANSITION.

THAT IS FINAL AS OF MARCH 3, 2009.

SO WE NOW -- ALL THE AGENCIES ARE UTILIZING ADOBE FACED FORMS.

THE ADOBE VERSIONS, THE LINK HERE ON THE CHART TAKES YOU TO OUR WEBSITE WHERE WE HAVE A TABLE SHOWING YOU THE VERSION THAT ARE USEABLE WITH GRANTS.GOV.

SO NEXT, ONE OF THE THINGS WITH THE RECOVERY ACT, WHAT WE'VE DONE IS WE'VE CREATED, ON MARCH 6, AN AREA ON OUR SITE WHERE WE HAVE THE ACTUAL RECOVERY, 400 PAGE RECOVERY ACT ITSELF.

WE HAVE SOME OTHER GUIDANCE AND SOME OTHER INFORMATION ON THERE.

BUT THE KEY IS WE TRACK, WE HAVE THE OPPORTUNITIES SPECIFICALLY FOR THE RECOVERY ACT POINTED OUT.

AS OF APRIL 13 THERE WERE 73 OPPORTUNITIES ON THERE.

SO WHEN AGENCIES POST THEIR OPPORTUNITIES, WHAT THEY DO IS THERE ARE CERTAIN GUIDELINES THEY FOLLOW TO IDENTIFY THEM SO THAT THEY DO POP UP UNDER THE RECOVERY ACT OPPORTUNITIES THEMSELVES.

THIS PAGE, AS I MENTIONED, WE HAVE OVER 5 MILLION PAGE VIEWS.

IN THE MONTH OF MARCH ALONE WE HAD 104,000 PAGE VIEWS JUST ON THAT.

ONE OF THE MAJOR THINGS COMING UP IS APRIL 27, IRONCIALLY, HAVE 27 CLOSINGS ON THAT DAY.

THE MAJOR ONE IS THE APRIL 27 LARGE NIH CLOSING.

AT THIS POINT, OVER 15,000 PEOPLE HAVE DOWNLOADED THAT APPLICATION PACKAGE.

SO WHAT ARE WE DOING TO PREPARE FOR THIS ADDITIONAL EXPECTED INCREASE IN VOLUME?

FIRST THING WE'RE DOING IS THIS WEEKEND, APRIL 18 AND 19 WE ARE DOING A BUILD, A SYSTEM BUILD.

SO THE SYSTEM WILL BE UNAVAILABLE SATURDAY AND SUNDAY, APRIL 18 AND 19.

WHAT WE ARE DOING IS WE ARE RECONFIGURING WHAT'S CALLED OUR L, LIGHT WEIGHT DIRECTORY ACCESS PROTOCOL.

WHEN YOU LOG INTO THE SYSTEM, THAT IS HOW YOU LOG IN, THROUGH OUR LDAT, KEEPING IT A HI LEVEL, WHAT WE HAVE RIGHT NOW IS 4 SERVERS SPECIFICALLY FOR L-DAT. THOSE SERVES TODAY INTERACT WITH EACH OTHER.

MEANING IF YOU WERE TO GO IN RIGHT NOW AND CHANGE YOUR PASSWORD, IT COULD HIT ANYONE OF THOSE 4 SERVERS.

THEN WHAT HAPPENS IS THE OTHER 3 SERVERS ARE REPLICATED.

THIS WEEKEND WE'RE MAKING A CHANGE.

WE'RE GOING TO TAKE ONE MAIN SERVER AND MAKE THAT WHAT'S CALLED THE MASTER.

SO WHEN YOU COME IN AND CHANGE YOUR PASSWORD, IT WILL BE CHANGED ON THAT ONE SERVER, AND THEN THE OTHER THREE SERVERS WILL BE REPLICATED.

THIS MINIMIZES DUPLICATION, REPLICATION EFFORTS THAT ARE TAKING PLACE WHICH WILL STREAMLINE, IMPROVE THE EFFICIENCY OF THE SYSTEM.

NOW, ANOTHER KEY ONE, WHAT WE ARE DOING IS ADDING.

WE ARE ADDING A NEW FUNCTIONALITY FOR TRACK APPLICATIONS.

TODAY, TO TRACK YOUR APPLICATION, YOU HAVE TO LOG IN TO THE SYSTEM.

ONCE THIS BUILD TAKES PLACE OVER THE WEEKEND, YOU START IN MONDAY MORNING STARTING THE WORK DAY, IF YOU WANT TO TRACK YOUR APPLICATIONS, WE ARE CREATING A URL -- CREATING A URL.

YOU CAN ENTER UP TO 5 GRANT TRACKING NUMBERS TO GET THE STATUS ON EACH OF THOSE TRACKING NUMBERS WITHOUT LOGGING INTO THE SYSTEM.

WHERE YOU CAN CLICK ON IT AND IT WILL GIVE YOU THE STATING OF THAT GRANT TRACKING NUMBER.

SO WHAT WILL HAPPEN IS SAME THING, ONCE YOU GET IT, YOU CLICK ON IT, IT WILL TELL YOU PROCESSING.

IF YOU GO BACK IN A DAY OR 2 OR SEVERAL HOURS LATER IT WILL GIVE YOU A STATUS. SO THE KEY HERE IS TO REMEMBER YOU NO LONGER HAVE TO LOG INTO THE SYSTEM TO TRACK YOUR APMEXICOS. -- APPLICATIONS.

YOU CAN TRACK UP TO 5 GRANTS TRACKING NUMBERS BY CLICKING ON A URL WHICH WILL BE IN MONDAY WHEN YOU COME IN.

THIS WILL REDUCE THE STRAIN ON THE L-DAT.

THE MORE PEOPLE LOGGED INTO THE SYSTEM, THESE ARE CREATING SOME SYSTEM SLOWNESS.

THIS WILL ALLEVIATE THAT.

IF YOU DO WANT TO SEE ALL OF THE APPLICATIONS YOU HAVE SUBMITTED AS AN AOR, WHAT YOU HAVE TO DO IS LOG INTO THE SYSTEM AND LIKE TODAY, IT WILL SHOW YOU A LIST OF ALL YOUR APPLICATIONS.

SAME FOR THE E BUSINESS POINT OF CONTACT.

E BUSINESS POINT OF CONTACT LOGS IN, CAN SEE ALL THE APPLICATIONS SUBMITTED BY EACH AOR IN THE ORGANIZATION.

SO THE SITE WILL BE DOWN THIS WEEKEND, APRIL 18 AND 19 LIKE ALWAYS, WE DO A BUILD COMMUNITY.

WE WOULD SEND THAT OUT AND DISTRIBUTE IT TO THE COMMUNITY.

TEMPERATURE BE ON THE WEBSITE, ON THE BLOG, SO YOU CAN SEE SPECIFICALLY WHAT THE TRACK NEW FUNCTIONALITY IS.

AS PART OF THAT EFFORT, GLEN FIND WHO IS THE INSPECTOR GENERAL FOR THE DEPARTMENT OF JUSTICE WHERE I WORK, HE SET UP A SUBCOMMITTEE LED BY GLEN FINE, GRANT FRAUD SUBCOMMITTEE WHOSE PURPOSE IS TO HELP EDUCATE PEOPLE ABOUT GRANT FRAUD, HELP PREVENT IT, INCREASE PROSECUTION OF IT, AND THAT'S WHY I'M HERE TODAY, TO SHARE IN THE SHORT AMOUNT OF TIME WE HAVE SOME INFORMATION ABOUT GRANT FRAUD TO INCREASE PEOPLE'S AWARENESS OF THE ISSUE AND WHAT THEY SHOULD DO IF THEY'RE CONCERNED ABOUT IT.

THE PRIMARY MISSION OF ALL THOSE FOLKS IS TO PREVENTED, DETER AND DETECT FRAUD WAIST AND ABUSE AND MISCONDUCT BY THE AGENCY FOR WHICH THEY OVERSEE. THE FOCUS IS ALWAYS ON ECONOMY, EFFICIENCY, AND EFFECTIVENESS, AND AS YOU CAN SEE IMAGINE, MUCH OF THAT WORK DEEMS WITH EMPLOYEE MISCONDUCT MATTERS, BUT THE BULK DEALS WITH PROCUREMENT FRAUD AND GRANT FRAUD MARTS. THAT'S WHY YOU INVITED ME TO TALK ABOUT GRANT FRAUD. AND ALSO BEFORE I JUMP IN ANY FURTHER, THE RECOVERY ACT AS WE'VE ALREADY TALKED ABOUT TODAY, INCLUDES SIGNIFICANT AMOUNT OF GRANT FUNDING IN TERMS OF \$300 BILLION OR SO IN NEW GRANT FUNDS. NOW, ALL FEDERAL GRANTED FUNDS NEED TO BE USED PROPERLY AS AN OVERSIGHT MECHANISMS, BUT WING IF PASSING OF THE RECOVERY ACT IT'S EVEN MORE IMPORTANT THAT WE PAY ATTENTION TO THESE MATTERS. IT IS A -- IT'S AN INFLUX OF \$300 BILLION INTO THE ECONOMY FOR SPECIFIC PURPOSES. WE NEED TO MAKE SURE ARE USED WISELY. I THINK MOST OF THAT MONEY IS USED APPROPRIATELY AND WISELY AND PROPERLY DOCUMENTED, BUT WE KNOW FROM EXPERIENCE AND THE GRANT FRAUD SUBCOMMITTEE KNOWS FROM A LOT OF EXPERIENCE THAT PROBLEMS CAN AND DO OCCUR. IT'S IMPORTANT WE'RE AWARE OF THE PRIMARY RISKS. I WANT TO RUN DOWN 3 OF THEM BRIEFLY. GRANT AGREEMENTS ARE ESSENTIALLY A PROMISE BETWEEN A GRANTING AGENCY LIKE HHS OR EPA OR WHATEVER AGENCY, AND AN INDIVIDUAL GRANTEE TO DO SOMETHING SPECIFIC FOR WHICH THE GOVERNMENT WILL PAY THE COST OF. BUT ALONG WITH THE AGREEMENTS COME A LOT OF REQUIREMENTS TO FOLLOW THE OFFICE OF MANAGEMENT AND BUDGET CIRCULARS, TO FOLLOW INDIVIDUAL AGENCIES POLICIES, AND THEM TO FOLLOW A WHOLE HOST OF ACCOUNTING AND AUDITING STANDARDS TO PROPERLY DOCUMENT THINGS. THE 3 PRIMARY ISSUES THAT COME UP, I WANT TO MAKE SURE THE VIEWERS ARE AWARE OF TODAY, NUMBER ONE, CONFLICTS OF INTEREST. THERE CAN AND ARE INSTANCES WHERE PEOPLE USE SOME OF THE THIS GRANT MONEY THAT IS A PERSONAL CONFLICT OF INTEREST, THEY HIRE THEIR RELATIVES, THEY ENGAGE IN SELF-DEALING BEHAVIORS BY HIRING A CONTRACTOR THAT THEY HAVE A RELATIONSHIP WITH, THAT THEIR SPOUSE WORKS FOR OR A COMPANY THAT THEY ESTABLISH AND THOSE THINGS CAN AND DO HAPPEN. THEY'RE DIFFICULT, SOMETIMES, TO DETECT. AND OFTEN DIFFICULT TO ASSESS AND DETERMINE THE DAMAGES THAT HAVE BEEN CAUSED BY THOSE, BUT THEY DO OCCUR. THE SECOND ONE, PROBABLY THE MOST PERTINENT TO THE RECOVERY ACT IS THAT THESE GRANT FUNDS HAVE TO BE USED FOR THE PURPOSE THEY'RE AWARDED FOR. FOR INSTANCE, IF AN ENTITY -- DEPARTMENT OF ENERGY, ALTERNATIVE ENERGY RESEARCH MONEY WHICH IS AN IMPORTANT ISSUE WE NEED TO DEAL WITH, THAT GRANTEE HAS TO USE THAT MONEY FOR THAT EXACT PURPOSE. THEY CAN'T REDIRECT THE USE OF THE MONEY, THEY CAN'T DECIDE THAT THEY'RE GOING TO USE IT IN A BETTER WAY TO RESEARCH OTHER ISSUES. GRANTEES HAVE TO USE THE MONEY AS INTENDED, AS AGREED.

EQUAL TO THAT AND RIGHT ALONG WITH IT, GRANTEES HAVE TO PROPERLY DOCUMENT AND ACCOUNT FOR HOW THEY USE MONEY. IT'S GOOD IF THEY I COULDN'T IT PROPERLY. IF THEY DON'T DOCUMENT THE PROPER USE, THAT WILL CAUSE A LOT OF PROBLEMS DOWN THE ROAD WITH AUDITS AND POTENTIAL RECOVERY OF FUNDS. GRANTEES HAVE TO USE IT AS THEY AGREE. THEY HAVE TO DOCUMENT IT. THAT COULD BE A PROBLEM IN A VARIETY OF WAYS WITH ACCOUNTING RECORDS, TIME SHEETS, CONTRACTS, THOSE KIND OF THINGS. THE FINAL ISSUE, THE SIMPLE THEFT OR EMBEZZLEMENT OF GRANT FUNDS, THE BEST WAY TO APPROACH THAT IS TO EASTERN SURE THAT EVERY GRANTEE HAS A GOOD SYSTEM OF INTERNAL CONTROLS, SEPARATION OF DUTIES, AND HAVE A GOOD MECHANISM TO ENSURE THAT EVERY DOLLAR, EVERY FEDERAL DOLLAR OR OTHER DOLLAR FOR THAT MATTER IN A FLOWS THROUGH THEIR HANDS IS USED PROPERLY, AND THEY HAVE GOOD CONTROL OF CHECKING ACCOUNTS, CREDIT CARDS, AND TO ENSURE THEY HAVE CONFIDENCE THAT THE MONEY IS BEING USED PROPERLY. >> THAT'S A GOOD QUESTION.

THE FIRST ANSWER IS IT ALWAYS TAKES TIME AND EFFORT TO FIGURE OUT THE EXACT FACTS.

WHAT EXACTLY HAPPENS?

IS THIS MISTAKE, SOMETHING INTENTIONAL?

ONCE WE COLLECT THE FACTS AND FIGURE OUT WHAT EXACTLY HAS HAPPENED, VARIETY OF THINGS CAN HAPPEN.

AT THAT BARE MINIMUM, WE COULD RECOMMEND IMPROVED CONTROLS, RECOMMEND TO THE GRANTING AGENCY THAT THEY TAKE SOME EXTRA PRECAUTIONS.

THERE CAN BE THE ADMINISTRATIVE RECOVERY OF FUNDS, AT THE END OF THE DAY, A GRANT AGREEMENT IS ESSENTIALLY A COST REIMBURSEMENT AGREEMENT IN MOST ASPECTS.

SO IF A GRANTEE CAN'T PROPERLY SUPPORT A COST OR IT'S NOT APPROPRIATE TO THIS PROGRAM, AT THAT MINIMUM WE CAN ASK FOR THE MONEY BACK.

THEN YOU MOVE UP THE SPECTRUM INTO ISSUES OF NEGLIGENCE ARE TYPICALLY DEALT WITH THROUGH CIVIL FALSE CLAIMS, CIVIL LAW SUITS OR OTHER LAW SUITS RELATED TO FRAUD AND OVERPAYMENT ISSUES.

>> I THINK THE MOST IMPORTANT ISSUE WITH PREVENTING GRANT FRAUD IS NUMBER ONE, TO ENSURE GRANTEES ARE AWARE OF SPECIFIC RISKS.

FOR INSTANCE, IF A GRANTEE HAS RESEARCH MONEY, THERE ARE COMMON ISSUES THERE WITH TIMECARDS AND MAYBE CONTRACTS AND LEVEL OF EFFORT ISSUES THAT NEED TO BE DISCUSSED AND CLARIFIED VERSUS A HIRING GRANT SPECIFICALLY TO HIRE POLICE OFFICERS, ISSUES WITH HOW MANY OFFICERS DID WE HIRE, HOW WILL WE ACCOUNT AND DOCUMENT FOR THAT.

I THINK THE FIRST THING IS MAKE SURE THE GRANTEES ARE AWARE OF SPECIFIC RISKS. SECOND EQUALLY IMPORTANT PART OF THAT IS THEY NEED TO DESIGN PROPER INTERNAL CONTROLS AND EDUCATE EVERYONE INVOLVED IN THE PROGRAM ABOUT THE IDENTIFIED RISKS AND THINGS THEY WILL DO TO REDUCE THE RISKS.

THE MORE GRANTEES ARE AWARE OF THE RISKS AND DISCUSS THEM, AND THE MORE PEOPLE THERE ARE, CONSIDERING THESE THINGS, THE BETTER JOB EACH GRANTEE CAN DO OF REDUCING THE IMPACT OF THEIR ORGANIZATION.

THERE IS NO WAY TO 100% PREVENT DEMISE USE OF ANY OF THIS GRANT MONEY, BUT I THINK BY BEING AWARE OF THE RISKS, TALKING ABOUT RISKS AND TAKING CERTAIN PREVENTIVE MEASURES WE CAN CERTAINLY REDUCE THAT RISK LEVEL LOWER THAN IT IS WITHOUT THE STEPS BEING TAKEN.
