This request is made under the Freedom of Information Act by Chapter 228 of the National Treasury Employees Union, the bargaining agent for a large group of employees in the Department of Energy, Germantown, MD. **At this time, the request is only for Information related to the e-mail , 10 Most Handsome Guys wait for marriage proposal and any variation there of, from the period beginning January 1, 2008 to June 2, 2008.** At this time, the request for the information is limited to 'sender's whose organizational code is in CF-10, CF-11, and/or CF-12.

We request, with the names redacted, a list of disciplinary actions taken against any of the senders of the e-mails. The list should indicate sender's grade; approximate age; managerial/supervisory/bargaining unit/non-bargaining unit status; and ethnicity and/or any other protected group status as defined by EEO.

We request any additional written documents, memoranda, briefing materials, diaries, correspondence, electronic messages, telephonic messages, notes concerning telephonic messages, log books of telephone calls, log books of fax messages, and any and all handwritten messages, notes, or 'buck' slips which might relate to the subject e-mail or discussion of discipline regarding the e-mail. At this time we limit our request to the Office of Finance and Accounting; Immediate Office of the Chief of Information; and the Office of Human Capital Management.

This information may be used to determine if there is actual or de facto discrimination against any protected minority or other group. The information may also be used to determine whether or not DOE routinely punishes managers/non-managers/bargaining unit/non-bargaining unit employees differently for the same offense. It may also be used to begin an inquiry into the systemic behavior of DOE to 'cover-up' inappropriate or illegal actions of managers and supervisors.

We also request a list of the average time it takes DOE to respond to a Union request for information regarding potential misuse of e-mail and a management request for potential misuse of e-mail.
