Project Name: A Child is Missing - Arkansas

Recipient: A Child Is Missing

Project Location: Arkansas Statewide

FY10 Request: \$350,000

Project Purpose:

This request would help A Child is Missing (ACIM) assist all of the law enforcement agencies in Arkansas in locating missing children and elderly adults. The program is available free of charge to all 431 Arkansas law enforcement agencies. Funds would be used for maintaining and upgrading ACIM's telephone technology, its Arkansas call lists, and outreach efforts.

Project Name: Arkansas Methamphetamine Education and Training Program

Recipient: Criminal Justice Institute, a part of the University of Arkansas System

Project Location: Little Rock, Arkansas

FY10 Request: \$575,000

Project Purpose:

This funding request would support the Criminal Justice Institute's efforts to continue providing methamphetamine-focused courses for the Arkansas law enforcement community that will emphasize officer awareness and safety, promote effective management and investigation of methamphetamine-related cases, and continue Arkansas's drug-endangered children (DEC) initiative. To increase the number of officers and communities that will benefit from these programs and also reduce the costs of expanding CJI's DEC initiative statewide, several select courses will be delivered using on-line/web-based delivery.

Project Name: Arkansas Research & Education Optical Network
(AREON) Campus Network Expansion

Recipient: University of Arkansas – Fort Smith

Project Location: Fort Smith, Arkansas

FY10 Request: \$240,000

Project Purpose:

AREON is a consortium of research and education institutions and public service agencies that was formed to foster the development of Arkansas's research, education, public service, and economic development. Funding would provide the University of Arkansas – Fort Smith with campus-wide access to AREON for expanded student and faculty research, collaboration with academic colleagues, and cooperative efforts with area industry.

Project Purpose:

Funds would support the Arkansas School Resource Officer Program at the Criminal Justice Institute. The Arkansas School Resource Officer Program offered by the Criminal Justice Institute has three primary components: [1] education and training on school safety-related issues for school resource officers, security officers, and school officials; [2] school safety and assessment; and [3] school crisis intervention and management.

Project Name: Arkansas Wireless Information Network (AWIN) Radio Replacement

Recipient: Arkansas Department of Information Systems

Project Location: Little Rock, Arkansas

Request: \$3,936,000

Project Purpose:

AWIN is a state-wide interoperable communications system that provides communications for 13,000 emergency responders across Arkansas. AWIN utilizes a mix of 700/800 MHz frequencies. The current radios in service can only receive transmissions in the 800 MHz frequencies. Due to the FCC's rebanding in the 800 MHz range, and the reallocation of the 700 MHz spectrum, these 800 MHz radios could pose a safety issue if the emergency responder is working in an area where 700MHz spectrum is in use on the system. Funds would be used to purchase radios that can receive transmissions in both the 700 and 800 MHz range. This will provide emergency responders in Arkansas more reliable communication channels.

Project Name: Arkansas Wireless Information Network (AWIN) Redundant Smart Zone Controller

Request: \$4,100,000

Project Purpose:

AWIN is a state-wide interoperable communications system that provides communications for 13,000 emergency responders across Arkansas. The AWIN system is comprised of two Smart Zone Controllers, and 104 remote communication tower locations. The Smart Zone Controllers provide for the management and routing of radio transmissions by emergency responders and are critical components of the AWIN System. Currently, if there is a failure of one of the existing controllers approximately half of the emergency responders in Arkansas are left without wide-area communications. Funding would be used to purchase and install a redundant Smart Zone Controller at the Arkansas Department of Emergency Management.

Project Purpose:

The Arkansas World Trade Center is a non-profit organization comprising local, regional, and statewide business, government, and education leaders that is designed to meet this need. This request will help sustain the Center's mission of supporting trade initiatives, providing information for small to medium sized businesses in Arkansas, and offering students international trade experience. Specifically, these funds will (1) support trade missions to promote Arkansas products and companies in foreign markets; (2) support trade seminars and summits; (3) provide training for companies and executives in international trade; (4) support statewide travel that will connect Arkansas businesses to the AWTC through local presentations; and (5) purchase computers for student interns at the AWTC.

Project Name: Baxter County Sheriff's Office - Aircraft Replacement

Project Purpose:

The Baxter County Sheriff's Office has an established aviation unit that serves the local and surrounding jurisdictions for a variety of criminal justice purposes including: drug eradication operations, high risk arrests and searches, fugitive tracking, and search and rescue missions. The age of the current helicopter has caused concerns in the Sheriff's Office with regard to mechanical and structural issues. Funding would be used to replace the helicopter with a used, but newer aircraft.

Project Name: Cyber Crimes Investigation Training Initiative

Project Purpose:

The purpose of this initiative is to create better-educated law investigators who are fully equipped to deal with all phases of cyber crime investigation. Funding will be used to develop a cyber crimes investigation course with the goal of delivering training to at least 160 Arkansas law enforcement officers.

Project Name: Electronic Control Device Acquisition

Project Purpose:

Funding would be used to purchase electronic control devices, cartridges, holsters, docking stations, and audio/visual capture devices. Such devices would provide a less than lethal alternative for subduing combative individuals. The addition of audio/visual capture devices would allow for the factual depictions of such situations for evidence in judicial proceedings.

Project Name: Forrest City, Arkansas Prison Expansion

Project Purpose:

These funds are needed to conduct an environmental assessment, feasibility study, and initial design work for the addition of a High Security Facility to the Forrest City Federal Correctional Complex. The land needed for a future construction phase has already been secured by the Forrest City Federal Correctional Complex. Additionally, the local community has provided critical infrastructure such as water lines and utilities that would be needed at a new facility.

Project Purpose:

The Arkansas State Police has the responsibility to serve as the state's only law enforcement agency with statewide jurisdiction and is attempting to fulfill its mission with a 35-year-old helicopter.

Responsible management of the Arkansas State Police requires a basic preparedness to respond to potential acts of terrorism, the possibility of a pandemic outbreak, and natural disasters. Funding would be used to purchase a larger, faster and more efficient rotary-wing, police-equipped aircraft to respond to a full range of aerial missions to protect and serve Arkansans.

Project Purpose:

Funding would be used to support the national anti-sexual assault initiatives that are authorized by section 628 of Public Law 109-248. These initiatives include two national hotlines for sexual assault victims, as well as RAINN's public education and outreach programs regarding the incidence of sexual violence and rape prevention, prosecution, and recovery.

Project Name: Juvenile Delinquency Prevention Program

With these funds, Save the Children will collaborate with and train local school partners in East Arkansas to implement structured supplementary literacy services for programs after school and during the summer. Funds will be used for curriculum and assessment materials, books, technology, and other supplies in addition to ongoing training and technical assistance, monitoring, and evaluation.

The River Valley Mobile Data Project would serve nine member agencies in Sebastian County.
