

## **FY2010 Transportation, Housing and Urban Development, and Related Agencies Appropriations Project Requests**

### **Federal Aviation Administration**

**Project Name:** Airport Runway Extension  
**Recipient:** Fort Smith Regional Airport  
**Project Location:** Fort Smith, Arkansas  
**Request:** \$1,500,000

**Project Purpose:**

To ensure the Fort Smith Regional Airport can continue to be fully functional for use by the U.S. Department of Defense through the Air National Guard and various itinerant military uses, the main east-west runway must be extended by 1,000 feet to 9,000 feet in total length. Also, the Fort Smith region has been contacted numerous times by industrial prospects interested in locating aviation-related businesses on airport property. A longer runway would mean a greater chance of attracting new aviation related industries to Fort Smith.

**Project Name:** Approach Light System (MALSR) for Runway 4 at Walnut Ridge Regional Airport  
**Recipient:** Walnut Ridge Airport Commission

**Request:** \$500,000

**Project Purpose:**

This request would support for the installation of an approach lighting system at the Walnut Ridge Regional Airport. Enhancement of the Walnut Ridge Regional Airport from a non-precision instrument approach airport to a precision instrument approach airport would be a significant step forward in terms of benefits to the Boeing 737 and McDonald Douglas 80 series airline-type aircraft using the airport on a monthly basis.

**Project Purpose:**

Funding is needed to begin construction on an access road from I-530 to the planned Technology Campus in Jefferson County.

**Project Name:** Belding Street Roadway Extension to US Hwy 270

**Project Location:** Hot Springs, Arkansas  
**Request:** \$150,000

**Project Purpose:**

Funding will be used to extend Belding Street one block to Hwy 270 in Hot Springs.

**Project Name:** Big Dam Bridge West Ramp

**Request:** \$3,000,000

**Project Purpose:**

This project will create another ramp for the Big Dam Bridge, which will improve accessibility. The ramp will eliminate the intersection where riders departing the bridge eastward must stop or slow to a walking speed to go west on the trail.

**Project Name:** Blytheville Overpass

The street extension will also dramatically reduce response time for fire, EMS, and other emergency vehicles to these high traffic facilities.

Funds will be used to make interchange improvements along U.S. Highway 63 in Jonesboro, Arkansas. The intersections at Southwest Drive, Harrisburg Road, Caraway Road, and Stadium Boulevard have become dangerous and studies show that increased traffic in the next 5 to 10 years will back up for miles off the exits onto the future interstate.

This segment is part of future Interstate 49, the north-south corridor from Kansas City, Missouri to Shreveport, Louisiana which was designated by Congress as High Priority Corridor 1 in the 1991 Intermodal Surface Transportation Efficiency Act (ISTEA).

**Project Purpose:**

In an effort to address safety needs and the adverse impact of congestion in an area of heavy pedestrian traffic, funds are requested for a joint project to improve access to the University of Arkansas campus from Interstate 540 along Razorback Road and Maple Street on Highway 112.

**Project Name:** Hwy. 167: Louisiana State Line to Sheridan

**Project Purpose:**

This request is for the development and construction of a project to complete the widening of Highway 167 to a four-lane arterial between the Louisiana State line and the City of Sheridan. This segment is part of an ultimate 4-lane arterial connection between the Louisiana State line and Interstate 530.

**Project Name:** Highway 226: Highway 67 to Highway 49  
**Recipient:** Arkansas State Highway and Transportation Department  
**Project Location:** Craighead County, Arkansas  
**Request:** \$20,000,000

**Project Purpose:**

This request is for the development and construction of a project to widen Highway 226 to a four-lane, divided facility on an existing location between two interstate-type facilities, the new location of Highway 67 and Highway 63 (Future Interstate 555) in Jonesboro. Widening Highway 226 will improve commodity flow with shorter travel times, which will help the region's economy by reducing the cost of doing business.

**Project Name:** Highway 412: Springdale Bypass

**Project Purpose:**

This request is for the development and construction of a project to relocate a segment of Highway 412 by constructing a four-lane freeway type facility that will provide a northern bypass of the City of Springdale. Highway 412 is part of the east-west corridor from Tulsa, Oklahoma to Nashville, Tennessee, which was designated by Congress as High Priority Corridor 8 in the 1991 Intermodal Surface Transportation Efficiency Act (ISTEA). The recipient will be the Arkansas State Highway and Transportation Department.

**Project Name:** Interchange at State Hwy. 89 and I-40 in Lonoke

**Project Purpose:**

This project includes constructing a new on and off ramp to and from I-40 and Highway 89. Highway 89 has an accident rate above the average for rural highways. The proposed project will re-route traffic volumes from these areas lessening the increased accident rates to these areas.

**Project Name:** Interstate 40: New Conway South Interchange

**Project Purpose:**

The Federal Highway Administration has approved a Draft Environmental Impact Statement identifying the location of the Conway Western Arterial Loop to meet current and future traffic needs. An essential element of this proposed new location route is to provide additional arterial route capacity in western Conway. This new location route will connect at the north and south with Interstate 40 which is a major east-west route.

**Project Purpose:**

Pulaski County and the City of Maumelle are working together to extend Counts Massie and make needed improvements. Engineering has already been done on Counts Massie to the site of the proposed interchange. This project would provide a needed third entrance to the city.



**Project Name:** Interstate 40: Mississippi River Bridge Seismic Retrofit

**Project Purpose:**

This project will complete the seismic retrofit of the Interstate 40 bridge over the Mississippi River between Arkansas and Tennessee at Memphis.

**Project Name:** Interstate 430/630: Interchange Modification

**Project Location:** Little Rock, Arkansas  
**Request:** \$20,000,000

**Project Purpose:**

This request is for the development and construction of a project to modify the Interstates 430/630 Interchange in west Little Rock. Planned improvements will modernize a 25-30 year old cloverleaf interchange between two major urban interstates to eliminate severe congestion during peak travel periods.

**Project Name:** I-530 Connector  
**Recipient:** Arkansas State Highway and Transportation Department  
**Project Location:** Southeast Arkansas  
**Request:** \$10,000,000

**Project Purpose:**

This project is for the construction of a new-location, four-lane, controlled-access highway extending from Interstate 530 in Pine Bluff, Arkansas to Highway 278 near the planned I-69 Corridor.

**Project Name:** Interstate 540: Fayetteville-North  
**Recipient:** Arkansas State Highway and Transportation Department  
**Project Location:** Washington and Benton Counties, Arkansas  
**Request:** \$20,000,000

**Project Purpose:**

Interstate 540 is the transportation spine of the Northwest Arkansas region. The Northwest Arkansas region is the fastest-growing region in the state, both in terms of population and traffic volumes. Due to the rapid growth that is occurring in the region, traffic volumes have grown to levels that are producing urban traffic congestion. The commercial growth of the region has gravitated to the interchanges on I-540, resulting in queues that back up on Interstate ramps to such an extent that they occasionally interfere with Interstate operations.

**Project Name:** I-555 Access Road, Poinsett County

**Project Purpose:**

U.S. 63, future Interstate 555, provides the only transportation artery across the St. Francis River flood way. Once this roadway reaches interstate standards, cotton module trucks will be denied access under current law. Without addressing this issue, these vehicles would be forced to travel alternate routes over significantly longer distances on narrow state highways, greatly increasing the hazards to civilian traffic. This request will provide funding to complete construction.

**Project Name:** Interstate 69/Great River Bridge: Highway 65-MS Highway 1

**Project Purpose:**

This is a joint project with Mississippi for the construction of the substructure of the main Mississippi River Bridge. This bridge is a portion of a new-location, four-lane, controlled-access highway.

The roadway is mostly a 2-lane street connecting many neighborhoods to commercial areas and to a large junior high school. Numerous turning movements create congestion and delays. The project will complement additional Jenny Lind Road improvements currently under construction to the north.

**Project Purpose:**

Funds would be utilized to construct the Little Maumelle Pedestrian Bridge as a component of the Arkansas River Trail System. The Arkansas River Trail System serves as an important economic, quality of life, and recruiting tool for the region.

**Project Name:** Marion Overpass and Approaches  
**Recipient:** Arkansas State Highway and Transportation Department  
**Project Location:** Marion, Arkansas  
**Request:** \$6,000,000

**Project Purpose:**

Funds will be used to construct rail grade separation in Marion, Arkansas. There is presently no grade separation crossing over the BNSF tracks within 10 miles of Marion and there are approximately 42 trains per day that travel through the city on this line. There are 1,500 homes and numerous businesses that are cut off from emergency vehicle access should a train block both crossings.

**Project Name:** Pine Street and Cedar Street Relocation

**Project Purpose:**

The lack of rail service at the Yellow Bend Port is a major impediment to its operation and growth. A location/environmental assessment study to provide a rail line at Yellow Bend Port is nearing completion. These funds will be used to conduct planning and design work and for right-of-way acquisition.

**Project Name:** Rehabilitation of the Dardanelle and Russellville Railroad

**Recipient:** Dardanelle and Russellville Railroad

**Project Location:** Russellville, Arkansas

**Request:** \$4,776,810

**Project Purpose:**

Funds will be used to rehabilitate and repair the Dardanelle and Russellville Railroad. Some rail is worn and light for the 286,000 pound cars used today. In addition to replacing rail, all city street crossings will be rebuilt with new steel crossties and resurfaced with new asphalt to smoothly transition motor vehicle traffic over the railroad. A new concrete crossing will be installed at Arkansas State Highways 7 and 7T. The project also includes installation of rock ballast to support the rail and ties along the entire length of the railroad, which will promote better drainage and allow the track to be stabilized.
