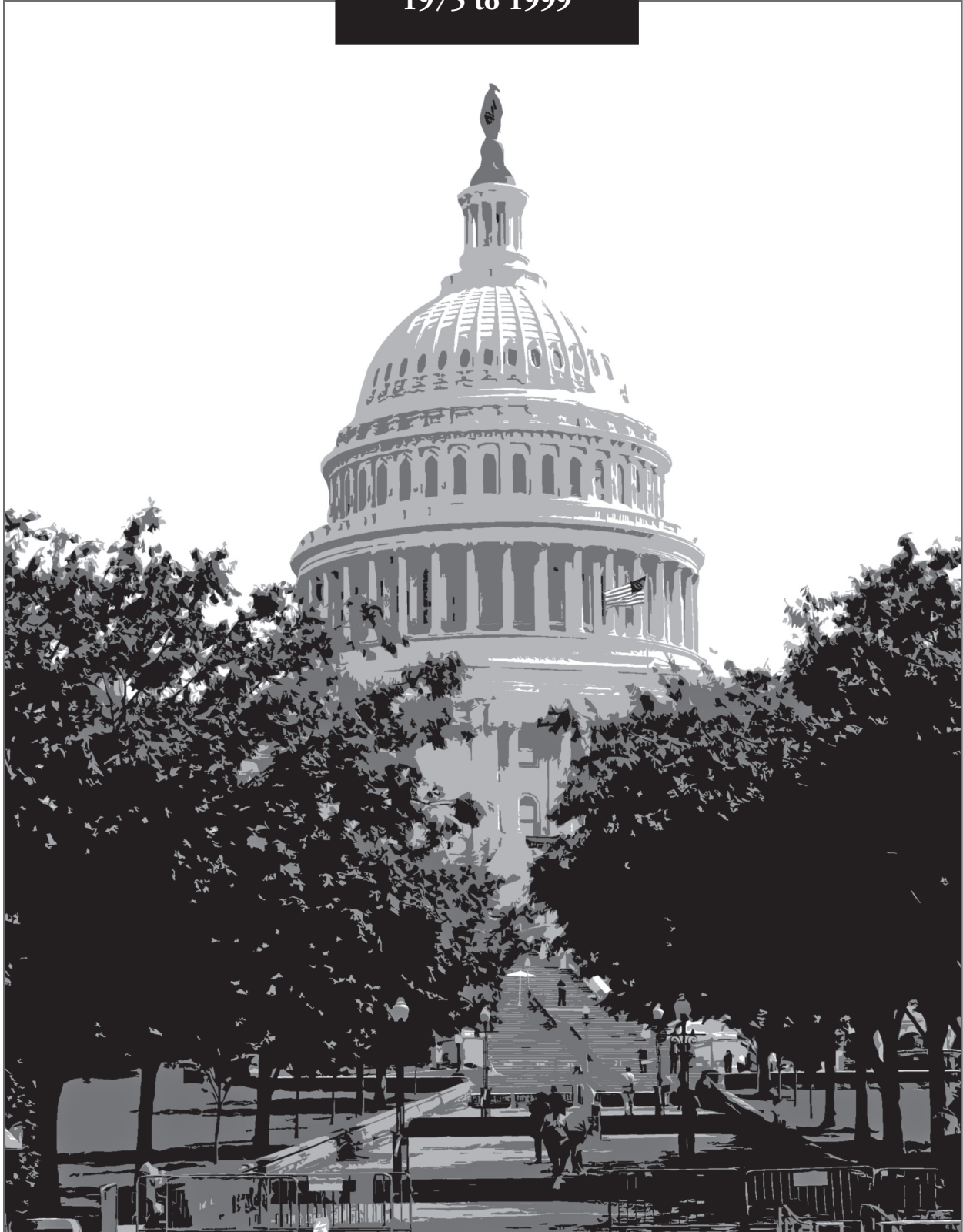

Foreword

Created by the Congressional Budget and Impoundment Control Act of 1974, the Congressional Budget Office (CBO) provides the Congress with budgetary information and analyses of budgetary, economic, fiscal, and programmatic policies. The agency began operation in February 1975 and published its first study in June of that year. This listing includes the agency's major publications—sorted by topic—from then through 1999. A companion volume lists the major publications from 2000 to the present. CBO publications are available to Members of Congress and their staff and to the general public.
