The key for SUMLEV is as follows:

050 = St-County and/or Statistical Equivalent

The key for SEX is as follows:

0 = Total

1 = Male

2 = Female

The key for ORIGIN is as follows:

0 = Total

1 = Not Hispanic Origin

2 = Hispanic Origin

Note: Hispanic origin is considered an ethnicity, not a race. Hispanics may be of any race.

The key for RACE is as follows:

- 1 = White Alone or in Combination
- 2 = Black or African American Alone or in Combination
- 3 = American Indian and Alaska Native Alone or in Combination
- 4 = Asian Alone or in Combination
- 5 = Native Hawaiian and Other Pacific Islander Alone or in Combination

Note: 'In combination' means in combination with one or more other races. The sum of the five alone or in combination race groups adds to more than the total population because individuals may report more than one race.

Note: The original race data from Census 2000 are modified to eliminate the "some other race" category. This modification is used for all Census Bureau estimates products and is explained in the document entitled "Modified Race Data Summary File Technical Documentation and ASCII Layout" that can be found on the Census Bureau website at <http://www.census.gov/popest/archives/files/MRSF-01-US1.html>.

Note: The 4,289 people in Clifton Forge city, VA, which was an independent city as of Census 2000, are not included in the April 1, 2000 Census enumerated population presented in the county estimates. In July 2001, the legal status of Clifton Forge changed from a city to a town and became dependent within (or part of) Allegheny County, VA. This population is now included in the April 1, 2000 estimates base and all July 1 estimates for Allegheny County. Note: The April 1, 2000 population estimates base reflects changes to the Census 2000 population from the Count Question Resolution program and geographic program revisions.

Note: The 3,436 people that were enumerated in the Skagway-Hoonah-Angoon Census Area in Census 2000, are not included in the April 1, 2000 Census population in the county estimates. In June 2007 the Skagway-Hoonah-Angoon Census Area split into Skagway Municipality and Hoonah-Angoon Census Area. There are no Census 2000 counts available for Skagway Municipality or Hoonah-Angoon Census Area because these entities did not exist at the time of Census 2000, however population counts do appear for both of these entities in the 2000 Estimates Base. Skagway-Hoonah-Angoon no longer exists so there are no longer any records for this entity in the population estimate files.
