

Pursuant to Title XV, Subtitle A, Section 1511 of the American Recovery and Reinvestment Act (Pub.L.111-5 (Feb, 17, 2009)) (ARRA), I, David J. Cieslewicz, Mayor of the City of Madison, hereby certify that the infrastructure investments funded with amounts appropriated by ARRA under the headings: "Transit Capital Assistance," and "Fixed Guideway Infrastructure Investment" to the Federal Transit Administration, have received the full review and vetting required by law and that I accept responsibility that such investments are appropriate uses of taxpayer dollars.
