REASE DELIVER THE FOLLOWING MESSAGE FROM VIETNAM	
"AMBASSADOR MARTIN HAS A SKED ME TO CONVEY TO YOU THE FOLLOWING MEMORAND UM ON BASIS OF WHICH AMBAMARTIN HOPES THAT YOU WILL BE ABLE TO EXERT SOME DISCREINFLUENCE IN ENSURING THAT THE IRANIAN DELEGATION IS STAFFED ADEQUATELY AT THE TOP LEVEL TO BEGIN WITH AND THAT IT WOULD ALSO BE STRENGTHENED IN THE QUANTITY AND QUALITY OF ITS DIPLOMATIC REPRESENTATION. AT PRESENT THE IRANIANS ARE A VERY POOR FOURTH WITH THE OTHER THREE NATIONS (HUNGARY, INDONESIA, POLAND) HAVING PIELDED VERY ABLE SENIOR PERSONNEL. OUR INTEREST IS OF COLORS NOT SO MUCH IN THE INDIVIDUALS THE IRANIANS DESIDE TO SEND MERE BUT IN THE FACT THAT AT PRESENT, AND PARTICLARLY NOTICEABLE SINCE THE DEPARTURE OF SADRY, OUR TWO COMMUNIST DELEGATIONS SIMPLOY OUTCLASS THE INCOMESTANS WHILE THE IRANIANS AT THE MOMENT JUST DON'T COUNT. CONSTAND PRESSURE ON THE COMMUNIST MEMBERS OF
ICS TO CARRY OUT THEIR RESPONSIBILITIES UNDER THE
PARTS AGREEMENT: IN SO DOING, E.WIDENCE OF POLISH AND
HUNBARIAN INSTANCEPITY WAS RECORDED AND EXPOSED IN THE
PART SESSIONS, CAUSING THEM EMBARRASSMENT., HOWEVER,
HIS DEPART UNE HAS LEFT THE IRANIAN DELEGATION WITHOUT
EFFECTIVE LEADERSHIP.

- 2. THE REFERENCED CABLE INDICATES THAT THE IRANIAN COVERNMENT IS CONSIDERING REPLACING SADRY WITH THEIR HESENI AMBASSADOR TO BANGKOK WHO IS ALSO ACCREDITED TO SAIGON. IF HE WOULD BE POSTED TO SAIGON TO WORK FULL TIME ON THE ICCS THIS WOULD BE A FINE SOLUTION. ON THE OTHER HAND, IF HE WOULD RETAIN HIS PRESENT FUNCTIONS AND ALSO ASSUME THE ICCS ACCREDITATION, THIS WOULD LEAD TO PROBLEMS AS THE SOUTH VIETNAMESE HAVE POINTED OUT THAT IT WOULD BE IMPOSSIBLE FOR THEM TO ACCREDITATION FOR ONE AND THE SAME PERSON AS AMBASSADOR TO THEIR GOVERNMENT AND CONCURRENTLY REPRESENTATIVE TO THE ICCS, IN WHICH POSITION HE WOULD HAVE TO DEAL WITH THE PROS. THE EMBASSY INFORMALLY INDICATED THIS VIETNAMESE CONCERN TO THE IRANIAN DELEGATION, HOWEVER, MINISTER KHAZENI SENT WORD BACK THAT HE COULD NOT BRING THIS MATTER TO HIS GOVERNMENT'S ARTINION BECAUSE IT WOULD BE PRESUMPTUOUS OF HIM TO COMMENT ON THE SUITABILITY OF ANOTHER OFFICER FOR THIS ASSIGNMENT.

 MINISTER W. KHAZENI MOGGADAM, IS NOT CAPABLE OF HANDLING
 THIS ESSIENMENT. HIS LACK OF EXPERIENCE AT CONFERENCE
 DIPLOMACY, RETTRING BUREAUCRATIC TEMPERAMENT AND
 INABILITY TO BET THE MOST OUT OF HIS STAFF RESULT IN
 WERY POOR PERFORMANCE. HE IS FURTHER HANDICAPPED BY
 HIS POOR ENGLISH WHICH IS THE OFFICIAL LANGUAGE OF THE
 ISCS AND WHICH THE OTHER AMBASSADORS ON THE COMMISSION
 ALL SPEAK. A FURTHER COMPLICATION LIMITING KHAZENI'S
 CAPABILITY TO UNITE AND LEAD THE TRANIAN DELEGATION
 STEMS FROM A FELD WHICH DEVELOPED BETWEEN HIM AND

HE EMBASSY HAS RECEIVED RUMORS AND TEOMS FROM SOTH SIDES ADCUSING THE OTHER PARTY

LEAD SENAL CORRUPTION. THE TRUTH IN THESE ALLEGATIONS

HE PROSEIBLE SON OUR EMBASSY TO JUDGE, BUT AS A COMPOSE THE DIPLOMATIC DELEGATION RECENTLY LOST SUPPAL SPANF MEMBERS, AND THE REMAINING TWO JUNIOR OF THE FIGHT OF THE STAY OLEAR OF THE FIGHT AND FIND OTHER ASSIGNMENTS.

ONE INDICATOR AS TO THE CAPABILITY OF THE IRANIAN DIFFORMATIC DELEGATION TO COMPETE WITH THE OTHERS CAN BE SEEN IN THE COMPARATIVE SIZE OF THEIR DIPLOMATIC STAPPS. THE TRANSIANS NOW HAVE THREE DIPLOMATIC OFFICERS, THE INDOMESTANS SEVEN, THE POLES THIRTEEN, AND THE HUNGARIANS STATEEN. NUMBERS TELL ONLY A PART OF THE STORY. THE COMMUNISTS NOT ONLY HAVE MUCH LARGER STAFFS BUE THEY HAVE MANY SENIOR OFFICERS WHO HAVE HAD MUCH GREATER EXPERIENCE THAN THE TWO JUNIOR OFFICERS (A THIRD SECRETARY AND A JUNIOR ATTACHE) ON THE IRANIAN DELEGATION. THE WEAKNESS OF THE IRANIAN DIFLOMATIC STAFF IS ATTRIBUTED BY SADRY TO THE FACT THAT THE FORE IGN MINISTER WAS UNWILLING TO GIVE HIM THE SUPPORT HE NCEDED, AND WHAT LITTLE HE RECEIVED CAME BECAUSE OF THE PRIME MINISTER'S BACKING. SADRY ALSO INDICATED THAT UNLESS THE SHAH PERSONALLY TOOK AN INTEREST IN FINDING A COMPETENT REPLACEMENT, THE JOB WOULD GO BEGGING. IF THE SHAH ORDERS AN OFFICIAL TO TAKE A POST, HE CAN'T REFUSE, BUT NO ONE ELSE HAS THE AUTHOR ITY TO FORCE SOMEONE TO TAKE AN UNDESTRABLE ASSIGNMENT. NO COMPETENT OFFICIAL HAS SHOWN ANY INTEREST IN BELING POSTED TO THE ICCS." E+2 IMPDET STERE
