PER SONAL FOR THE CHARGE D'AFFIARES

- 1. WITH OHE DEPARTURE OF AMBASSADOR SADRY FOR ALGIERS, WE ARE FACING A PROBLEM WITH THE IRANIAN DELEGATION WHICH MAY EECOME A BIT STICKY UNLESS WE CAN FIND SOME WAY TO GRACEFULLY INTERCEDE TO PREVENT IT DEVELOPING INTO AN AWAYARD SITUATION RETWEEN THE GVN AND THE GOI.
- 2. ON 8 JANUARY THE IRANINAN ICCS DELEGATION SENT A NOTE TO THE RVN MILITARY DELEGATION TO THE CENTRAL TWO PARTY JOINT MILITARY COMMISSION SAYING THAT SADRY HAS BEEN REPLACED BY AMBASSADOR SADIGH ESPANDIARY, WHO IS PRESENTLY ACCREDITED AS IRANIAN AMBASSADOR TO SAIGON WHILE RESIDENT IN BANGKOK.
- 3. IT HAS NOT BEEN CLEAR WHETHER IT IS THE IRANIAN INTENTION TO REPLACE HIM AS AMBASSADOR TO THAILAND AND VIET-NAM. GENERAL HIEP THE SOUTH VIETNAMESE REPRESENTATIVE TO THE ICCS HAS CALLED IN THE IRANIAN CHANGE AND GENTLY ASKED WHETHER IE REALLY IS A GOOD IDEA FOR ONE MAN TO HOLD THE POST AS AMBASSADOR TO SAIGON WHILE ALSO HOLD ING THE SEMI-JUDICIAL POST AS HEAD OF THE ICCS DELEGATION. WHILE THERE IS A PRECEDENT FOR HAVING AN AMBASSADOR TO A COUNTRY OTHER THAN VIET-NAM ACT ALSO AS ICCS DELEGATION HEAD CINDONESIAN AMBASSADOR DHAR SOND WAS ACCREDITED TO PHNOM PENH WHILE SERVING AS HEAD OF THE INDONESIAN DELEGATION THERE IS NONE FOR THE FORMER CASE.
- A. TO MAKE MATTERS EVEN MORE DANGEROUS THE TRANSAN CHARGE MENDS WHAZENS MORBADAM IS AN IDIOT. HE CAME UP TO OUR ICCS LIAISON OFFICER AT THE ATRPORT AND IN THE PRESENCE OF THE POLISH AND HUNGARIAN CHARGES REPEATED WHAT HIEP HAD TOLD HIM, ELICITING FROM THEM THIS WAS AN INTERESTING QUESTION OF INTERNATIONAL LAW. WE CAN, THEREFORE, DEPEND ON OUR COMMUNIST FRIENDS TO EXPLOIT THE MATTER IN THE FUTURE.

I NAVE BEEN TOLD THAT THE IRANIAN CHARGE IS SO BAD THAT NO OF THE IRANIAN AMBASSADOR WILL HAVE HIM AND WHILE IN THE FOREIGN MINISTRY HE WAS IN CHARGE OF THE MAIL ROOM AND SPENT MOST OF HIS TIME DENOUNCING HIS COLLEAGUES TO SAVAK, AN ORGANIZATION WITH WHICH HE CLAIMS TO HAVE GREAT INFLHENCE. SADRY SENT HIM BACK TO TERMAN AND HE WAS PERMITTED TO RETURN ONLY AFTER DECISION HAD BEEN MADE TO ASSIGN SADRY TO ALGIERS. THE LOCAL IRANIAN MILITARY OFFICERS WILL IGNORE HIM.

G. SINCE HE WANTS VERY MUCH TO REMAIN AS CHARGE AS LONG AS POSSIBLE I ASSUME HIS REPORTING OF QUM, CONCERNS WILL BE DESIGNED TO PROMOTE THAT GOAL AND WILL NOT NECESSARILY BE PRECISE NOR

A FURTHER COMPLICATION IS THAT WE: UNDERSTAND ESFANDIARY IS AN EXCELLENT MAN BUT IS DOING EVER YTHING POSSIBLE TO AVOID TAKING THIS ASSIGNMENT, WHICH CONFIRMS HIS GOOD SENSE, AT LEAST, AND IS FINDING EVERY POSSIBLE EXCUSE TO DELAY HIS ARRIVAL IN SAIGON.

8. OFT IM UN SOLUTION WOULD BE TO HAVE ESPANDIARY REPORT HERE SOONEST WITH NO OTHER FUNCTION THAT ICCS. IF HE IS AS GOOD AS HE IS SUPPOSED TO BE HE WILL SUMMARILY DISPENSE WITH THE PRESENT CHARGE. HOWEVER, IF HE IS TO BE LONG DELAYED THEN A

IN ANY EVENT, IT WOULD BE VERY HELPFUL TO KNOW WHETHER THE CONTEMPLATES A DUAL ACCREDITATION.
