Re: FLC/SPIE Trade 2008

AGREEMENT

This Agreement dated 3 March 2008 by and between SPIE, a California non-profit corporation with its offices in Bellingham, WA and the Federal Laboratory Consortium (FLC), a U.S. Government entity with offices in Washington, DC.

Whereas SPIE conducts meetings and exhibits, and has many promotional and advertising vehicles (print and web-based), and FLC conducts meetings and exhibits, and also has many promotional and advertising vehicles (print and web-based, including a national newsletter entitled *FLC NewsLink*), and each organization desires to trade exhibit space at specific exhibitions and other promotional opportunities; the parties hereto agree as follows:

FLC will receive:

- One 10 x 10 exhibit booth space with basic furnishings (one 6' draped counter, 2 stools, carpet, wastebasket, company ID sign) at the following exhibit:
 - Optics & Photonics 2008 (OP08), to be held 12-14 August 2008 in San Diego, CA.
Freight and material handling charges are not included in this agreement.
- One full-week technical meeting registration fee (proceedings, banquets or short courses not included) at the following meeting:
 - Optics & Photonics 2008 (OP08) to be held 10-14 August 2008 in San Diego, CA.
- A link from the following SPIE-managed web sites to the FLC web site or a PDF of the FLC 2008 National Meeting, as designated, posted for one year:
 - Optics and Photonics Clusters: www.photonicsclusters.org (link to PDF)
 - SPIE.org Community services: (link to FLC web site)
 - SPIE's conference calendar: (link to PDF)
- One full-page four-color advertisement for FLC to be run in the following SPIE publication:
 - OP08 Exhibition Guide
- A one-time press release link from SPIE's Newsroom web site to copy provided by FLC.

SPIE will receive:

- One exhibit space at the 2008 FLC National Meeting Tech Fair with basic furnishings (6' draped table or equivalent, 2 chairs, carpet and wastebasket) to be held 5-8 May 2008 in Portland, OR.
Freight and material handling charges are not included in this agreement
- One full conference registration fee to the 2008 FLC National Meeting (does not include evening banquet).
- A link from the FLC and *Newslink* web sites to each SPIE meeting web site as follows:

The parties hereto agree that the market value of the goods or services received by SPIE is no less than equal to the value of the goods or services received by FLC, and that no further compensation or fee is due to either as a part of this transaction.
