FEES and CHARGES

Effective: June 1, 2008

DEFINITIONS

1. "Regular hours" means 7:00 a.m. to 4:30 p.m., Monday through Friday. Sampler regular hours may be adjusted to the elevator's hours of operation, but will not exceed eight hours per day. All hourly fees will be assessed in quarter-hour increments, per individual necessary to perform the service. Regular hourly rate and travel time rate will be charged at \$18.00 per hour.
2. "Overtime" means work performed during any hour other than the regular hours or holiday hours as defined. Overtime hourly rate will be charged at \$27.00 per hour.
3. "Travel time" means time spent in round trip travel from portal to portal. If an employee performs inspections at several locations on one trip, travel time may be prorated.

4. "Holidays" means:

New Years Day	Memorial Day	Fourth of July
Labor Day	Thanksgiving Day	Christmas Day

Holiday hourly rate will be charged at \$36.00 per hour.

5. "Call in" and "call back" means any work performed when the employee is called back to work after a regular work schedule.

Official inspection includes grading and sampling, except where indicated in the schedule.

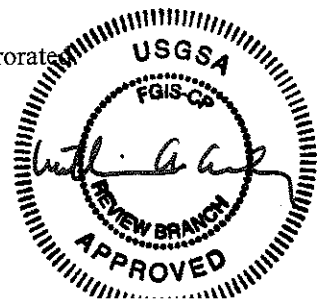
Official commercial inspection service is provided upon agreement between Kansas Grain Inspection Service, Inc and the applicant. Fees charged are dependent upon modification to the service. Inquiries should be forwarded to the Kansas Grain Inspection Service, Inc.(KGIS), P.O. Box 750077, Topeka, Kansas 66675.

The appropriate hourly rate will be applied for on site sampling, when applicant doesn't load more than four railcars per hour.

For on site inspection: If no unit rate contract is in effect, the appropriate hourly rate will be charged. If unit rate contract is in effect, two employees will be provided at no hourly rate, as long as applicant loads 5 carlots or more per hour.

Mileage: The IRS standard mileage rate will be assessed for all services performed outside the service point city's limit. Any change to the mileage rate is effective when the IRS changes their standard mileage rate.

Note: If inspections are performed at several points on a trip, the mileage expenses may be prorated.

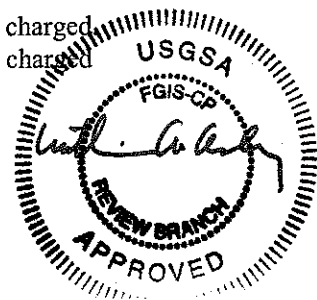
Diverter-type (D/T) review checktest visits at country points, regular hourly rate plus mileage.

Checktesting diverter-type (D/T) sampler at inspection points applicable hourly rate (1-hour min. charge)

When no fee for service has been established, the hourly rate will apply.

For those inspections for which fees are based on an hourly rate, neither the overtime hourly rate nor the holiday hourly rate will be applied in addition to the regular hourly rate.

If an employee is called in or back, a minimum of two hours at the overtime hourly rate shall be charged. Interest will be assessed on unpaid accounts which are in excess of 60 days. The rate of interest charged will be set by the KGIS trustees and will not exceed 18% A.P.R.
