**Grain Inspection Fees and Services  
Performed Under U.S. Grain Standards Act**

Effective January 15, 2009. Federal Grain Inspection Service must approve all fees for official services and official agencies will assess only fees appearing on their current approved schedule.

Stand by Time: Hourly rates will be assessed in quarter hour increments. Time for all applicant caused delays will also be assessed at the applicable rate.

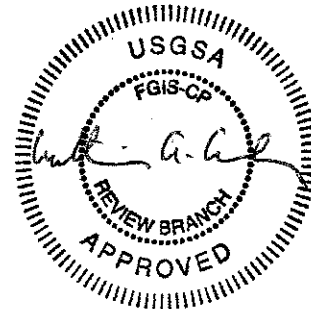
All requests are honored on a first call first serve basis.

Employee lunches: Elevator personnel must notify the Ohio Valley Grain Inspection, Inc. sampler when the lunch break is in effect. If elevator personnel do not inform the sampler of a lunch break, **NO LUNCH WILL BE DEDUCTED**. Applicants have the right for samplers to deduct for lunch break if the loading stops for an appropriate amount of time, but not to exceed one hour. All other times will be billed as Stand by Time.

Mileage: The IRS standard mileage rate will be assessed per mile actual miles travel. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage and travel time will be prorated where possible.

Travel Time: Mon-Fri will be assessed at regular sampling rates.  
Saturday will be assessed at overtime rate.  
Sunday and Holidays will be assessed at double time rate.

A service request for all samplers, inspectors, and weighers will be assessed a two-hour minimum, travel time, and mileage. Fees will apply if personnel have been dispatched. If cancellation occurs before personnel are dispatched no service fee will be applied.



Official Services: Do not include sampling fees, except as indicated. These charges include FGIS supervision fees and \*stowage examinations when applicable.

Service requests not covered by the above fees will be performed at the applicable hourly rate, travel time, mileage, and travel expenses when applicable.



TERMINOLOGY

Stand By Time: Applicant requests a sampler to stay on premises until loading commences.  
Cancellation: Applicant declines sampling services after the sampler has arrived or was in transit to the destination.  
Overtime Hours: O.T. will be charged if work commences at elevator before 8:00am and after 4:00pm.

GUARANTEED SERVICES CONTRACTS

Ohio Valley Grain Inspection, Inc. offers volume discounts. This offer applies to officially graded barges and officially graded railcars.

Discount Terms: Ohio Valley Grain Inspection, Inc. must officially grade ninety percent (90%) of all samples. The discount will apply to each of the carrier types meeting the 90% minimum requirement. The applicant's total volume is measured commencing with the contract date and ending twelve months from that date. The total volume must be verified through O.V.G.I.

Verification Conditions: Verification can be accomplished by submitting a statement of volume from each signatory (elevator) for the one year period covered in each contract. The volume verification statement must become part of the Ohio Valley Grain Inspection, Inc. official records and the signatory must allow FGIS assess to their volume records for the particular type of carrier and time period in question.

Penalties For Non-Compliance: Failure to meet minimum volume requirements will result in an additional billing to the amount of discount taken.

Fee Collection: Statements will be sent Bi-Monthly. Payment will be due fifteen days from statement date.

Any other request for inspection service will be handled as a request for service outside the contract, and applied to current schedule of fees and charges.

The following discount rates will be applied to guaranteed service contracts:

Barges	\$ 2.48
Railcars	\$11.60

All of the above charges also include stowage examinations.  
All the above discounts are a twenty percent discount per carrier, no daily minimum required, must be ninety percent of volume per contract year.
