GRAIN INSPECTION FEES AND CHARGES

EFFECTIVE DATE: June 1, 2008. The Federal Grain Inspection Service (FGIS) must approve all fees for official services and OAs will assess only those fees appearing on their current approved fee schedule. State and local taxes will be added as required.

REGULAR HOURS AND HOURLY RATES: Belmond Office: 7:30 a.m. to Noon and 1:00 p.m. to 4:30 p.m. Monday through Friday, except holidays and eves thereof. The **Albert Lea office** is staffed on an as needed basis. All sampling methods and onsite grading will be figured on M-F regular hours of 8:00 AM – 4:00PM. Assessed in quarter-hour increments, in addition to unit fees.

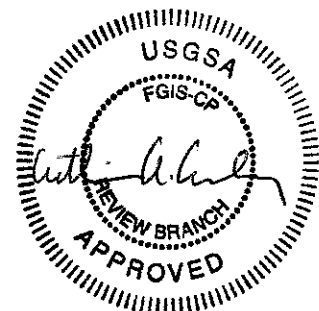
OVERTIME HOURS: One and one-half times the regular hourly rate for work performed on Saturday and other than regular hours, assessed in quarter-hour increments, in addition to unit fees.

HOLIDAY AND SUNDAY HOURLY RATES: Double the regular hourly rate assessed in quarter-hour increments in addition to unit fees. Holidays include: New Year's Day, Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day.

TRAVEL TIME: Assessed per individual at applicable hourly rate.

MILEAGE: The Internal Revenue Service standard rate will be the maximum assessed for actual miles traveled outside Belmond, IA or Albert Lea, MN location city limits, prorated whenever possible. Any change to the mileage rate is possible when the IRS changes their standard mileage rate.

STANDBY TIME: Assessed per individual at applicable hourly rate for applicant caused delays in quarter-hour increments.

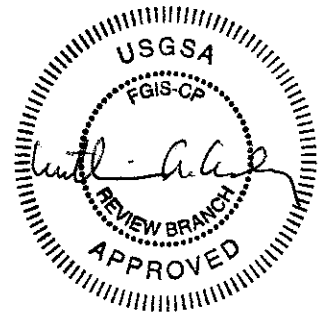
Other services will be assessed the applicable FGIS user's fee based on tonnage when not done in conjunction with official grading.

Delivery of official D/T mechanical samples to this office will be at the elevator's expense. If sampler attendant is requested to deliver samples, the sampler attendant hourly rate plus mileage will be assessed. Service requests not covered by above fees will be assessed the applicable hourly rate.

Onsite Inspection: Elevator must provide suitable lab space and all equipment. Staffing and equipment requirements will be determined by D. R. Schaal Agency, Inc. All labor will be charged at \$18.50 per hour, per person and is subject to overtime, holiday/Sunday rates. Basis depart/arrive Belmond lab, plus inspection fees and mileage.

Official Commercial Inspections are offered and fees will be negotiated on a case-by-case basis.
