JACUMBA WILDERNESS 31,130 Acres Designated October 31, 1994 by the California Desert Protection Act, Public Law 103-433

This is the final legal description as required in Section 103(b) of the above mentioned Act. It describes the boundary for the Jacumba Wilderness Area located in Imperial County, California and managed by the Bureau of Land Management. The boundary is more particularly described as follows:

Beginning at the corner of sections 4 and 5, T. 16 ½ S., R. 10 E., S.B.M., on the township line between Ts. 16 ½ and 17 S., R. 10 E., S.B.M., said point being the point of beginning;

thence easterly on said township line to point 1, the 1/4 section corner of section 3 only, T. 17 S., R. 10 E., S.B.M.;

thence southerly on the north/south centerline of said section 3 to point 2, the 1/4 section corner of sections 3 and 10;

thence easterly between sections 3 and 10, and sections 2 and 11, to point 3, the intersection of a line parallel with and 300 feet southwesterly of the centerline of State Highway 98;

thence southeasterly, parallel with and 300 feet southwesterly of said centerline, to point 4, the intersection of the north/south centerline of section 11;

thence southerly on said north/south centerline to point 5, the center 1/4 section corner of section 11;

thence easterly on the east/west centerline of section 11 to point 6, the intersection of a line parallel with and 300 feet southwesterly of the centerline of State Highway 98;

thence southeasterly, parallel with and 300 feet southwesterly of said centerline, to point 7, the intersection of a line parallel with and 30 feet westerly of the centerline of a jeep trail, said intersection located in the southeast 1/4 of section 11;

thence southerly, parallel with and 30 feet westerly of said centerline to point 8, the intersection of the line between sections 13 and 24;

thence westerly between sections 13 and 24, and sections 14 and 23, to point 9, the I/4 section corner of sections 14 and 23;

thence southerly to point 10, a knob near the center of section 23, and having NAD 1927 coordinates of 32°39'22" N. latitude, 115°55'47" W. longitude, as scaled from the U.S.G.S. 7 ½ minute Quadrangle "Coyote Wells, Calif.", 1957, photorevised 1979;

thence southeasterly to point 11, a knob located in the southeast 1/4 of section 23, and having NAD 1927 coordinates of 32°39'10" N. latitude, 115°55'24" W. longitude, as scaled from the U.S.G.S. 7 ½ minute Quadrangle "Coyote Wells, Calif.", 1957, photorevised 1979, and an elevation of 869 feet, as shown on said quadrangle;

thence South to point 12, the intersection of the section line between sections 23 and 26;

thence southeasterly to point 13, a point 30 feet southeasterly of the terminus of the centerline of a jeep trail located near the north 1/16 section corner of sections 25 and 26;

thence northeasterly, parallel with and 30 feet southeasterly of said centerline to point 14, the intersection of a line parallel with and 30 feet westerly of the centerline of a jeep trail, located in the south ½ of section 24;

thence southerly, parallel with and 30 feet westerly of said centerline to point 15, the intersection of a line parallel with and 60 feet northerly of the International Border between the United States and Mexico;

thence westerly, parallel with and 60 feet northerly of said International Border to point 16, the intersection of the line between sections 8 and 9, T. 18 S., R. 9 E., S.B.M.;

thence northerly between sections 8 and 9, and sections 4 and 5, to point 17, the 1/4 corner of sections 4 and 5;

thence westerly on the east/west centerline of section 5 to point 18, the 1/4 corner of sections 5 and 6;

thence northerly between sections 5 and 6, to point 19, the intersection of the township line between Ts. 17 and 18 S., R. 9 E., S.B.M.;

thence northerly between section 31 and 32, T. 17 S., R. 9 E., S.B.M., to point 20, the 1/4 corner of sections 31 and 32;

thence easterly on the east/west centerline of section 32 to point 21, the center-west 1/16 corner of section 32;

thence northerly on the north/south centerline of the northwest 1/4 of section 32, and the north/south centerline of the southwest 1/4 of section 29, to point 22, the southwest 1/16 section corner of section 29;

thence easterly on the east/west centerline of the southwest 1/4 of section 29 to point 23, the center-south 1/16 corner of section 29;

thence northeasterly to point 24, the intersection of the line between sections 20 and 29, with the westerly line of tract 37;

thence northerly on the westerly line of tract 37, to point 25, the intersection of a line parallel with and 300 feet southerly of the centerline of the east bound lanes of Interstate Highway 8;

thence northeasterly, parallel with and 300 feet southeasterly of said centerline to point 26, the intersection of the line between sections 16 and 21;

thence easterly between sections 16 and 21 to point 27, the corner of sections 15, 16, 21 and 22;

thence northerly between sections 15 and 16 to point 28, the north 1/16 corner of sections 15 and 16;

thence easterly on the east/west centerline of the northwest 1/4 of section 15 to point 29, the northwest 1/16 corner of section 15;

thence northerly on the north/south centerline of the northwest 1/4 of section 15 and the north/south centerline of



the southwest 1/4 of section 10, to point 30, the intersection of a line parallel with and 300 feet southeasterly of the centerline of the east bound lanes of Interstate Highway 8;

thence northeasterly, parallel with and 300 feet southeasterly of said centerline, to point 31, the intersection of the east/west centerline of the northwest 1/4 of section 2;

thence easterly on the east/west centerline of the northwest 1/4 and the east/west centerline of the northeast 1/4 of section 2 to point 32, the northeast 1/16 corner of section 2;

thence northerly on the north/south centerline of the northeast 1/4 of section 2 to point 33, the intersection of a line parallel with and 300 feet southerly of the centerline of the east bound lanes of Interstate Highway 8;

thence easterly, parallel with and 300 feet southerly of said centerline to point 34, the intersection of the township line between Ts. 16 and 17 S., R. 9 E., S.B.M.;

thence easterly on said township line to point 35, the intersection of a line parallel with and 30 feet westerly of the centerline of a jeep trail, located in the northeast 1/4 of section 1;

thence southwesterly, parallel with and 30 feet northwesterly of said centerline to point 36, the intersection of the northerly edge of a wash, said intersection located in the southeast 1/4 of the southwest 1/4 of section 1;

thence easterly on the northerly edge of said wash to point 37, the intersection of a line parallel with and 30 feet southeasterly of the centerline of said jeep trail;

thence northeasterly, parallel with and 30 feet southeasterly of said centerline to point 38, the intersection of the southerly edge of a wash, said intersection located in the northwest 1/4 of the southeast 1/4 of section 1;

thence East to point 39, the intersection of the range line between Ts. 16 1/2 and 17 S., Rs. 9 and 9 1/2 E., S.B.M.;

thence southeasterly to point 40, the corner of sections 1 and 2, T. 16 ½ S., R 9 ½ E., on the township line between Ts. 16 ½ and 17 S., Rs. 9 ½ E. and 10 E., S.B.M.;

thence South to point 41, the intersection of a line parallel with and 30 feet southerly of the centerline of a jeep trail located in the northwest 1/4 of section 6, T. 17 S., R. 10 E., S.B.M.;

thence easterly, parallel with and 30 feet southerly of said centerline to point 42, the intersection of a line parallel with and 30 feet westerly of the centerline of a jeep trail located in the northwest 1/4 of section 5;

thence southerly, parallel with and 30 feet westerly of said centerline to point 43, a point East of a knob, said knob located near the south 1/16 section corner of sections 5 and 6, and having NAD 1927 coordinates of 32°41'52" N. latitude, 115°59'14" W. longitude, as scaled from the U.S.G.S. 7 ½ minute Quadrangle "Coyote Wells, Calif.", 1957, photorevised 1979;

thence East to point 44, the intersection of a line parallel with and 30 feet easterly of the centerline of said jeep trail;

thence northeasterly, parallel with and 30 feet easterly of said centerline to point 45, the intersection of the township line between Ts. 16 ½ and 17 S., R. 10 E., S.B.M.;



thence easterly on said township line to the point of beginning.

END OF DESCRIPTION

The above description containing approximately 31,130 acres utilizes the In-Ko-Pah Gorge and Coyote Wells 7.5 minute quadrangle maps prepared by the USGS. The boundary calls listed herein are in part a result of scaling distances from said quad maps and are not a result of survey. All courses have been depicted upon the above mentioned quad maps and are made a part of this official record. Acreage is calculated from the California State Office ArcInfo wilderness coverage.

I hereby certify the legal description and map herewith represent the location of the boundary of the Jacumba Wilderness designated by the California Desert Protection Act, Public Law 103-433, dated October 31, 1994.
