CHANGE TO THE SPECIFICATIONS:

Delete paragraph 6.4 from Section 03150 - Expansion Joints and Waterstops

Delete paragraphs 5, 5.1, and 5.2 from Section 03601 - Epoxy and Epoxy Grout.

Add the following paragraphs to Section 03601 - Epoxy and Epoxy Grout:

- 5. Non-shrink Grout shall be used in lieu of Epoxy.
- 5.1. General. Descriptive literature of the grout proposed for use shall be furnished together with a certificate from the manufacturer stating that it is suitable for the application or exposure for which it is being considered. In addition, a detailed plan shall be submitted for approval, showing equipment and procedures proposed for use in mixing and placing the grout.
- 5.2. Prepackaged Material. Prepackaged material requiring only the addition of water will be accepted on the basis of certified laboratory test results showing that the material meets the requirements of ASTM C 1107. When fine aggregate is to be added, the Contractor shall also furnish for approval the mixture proportions together with certified copies of laboratory test results indicating that the mixture is in conformance with the requirements of ASTM C 1107.
- 5.3. Mixture Proportions. Mixture proportions using a volume-change controlling ingredient shall be submitted for approval. The submittal shall include the mixture proportions of all ingredients and certified copies of laboratory test results indicating that the materials and the mixture is in conformance with the requirements of ASTM C 1107.
- 5.4. Aggregates. Information identifying the aggregate source to be used along with gradation tests for fine and coarse aggregates shall be submitted for approval. The gradation test for fine aggregate shall include the No. 8 and No. 30 sieve sizes.
- 5.5. Water. The name of the source of mixing and curing water and documentation that mixing water meets CRD-C 400.
- 5.6. Placement. It shall be permitted that the 2nd pour of the non-shrink grout could be placed at the same time as the first, after placing the waterstop.
- 7.1 No measurement will be made for the work specified within this modification. Payment to revise the waterstop placement in the girders will be made at the contract lump sum price for "VE Waterstop Change" and "VE Payment for Waterstop Change".

CHANGE TO THE DRAWINGS: Revise contract drawing 35 of 79, FILE NO. H-4-40359, dated June 95, replace the detail of the Shear Key & Waterstop Blockout with the attached sketch SK-95-0093-01.

CHANGE TO CONTRACT PRICE: The contract price is decreased by \$25,527.70.

CHANGE TO CONTRACT TIME: The contract time is increased by 7 calendar days.


