Board Approved Ethics Courses Meeting Education Requirements for the Uniform CPA Examination

September 17, 2009

The following ethics courses were evaluated by the Qualification Committee and approved by the Texas State Board of Public Accountancy to meet the criteria as defined by Board Rule 511.58. The university was advised of this action, and also informed that reevaluation of the course would be necessary if a significant change was made to the course content that directly relates to the Board's definition of an acceptable ethics course. The Board should be notified if: changes are made to the course pertaining to the instructor, method of delivery, syllabus, course content, the course number, or course title; or, if the university adds instructors or chooses not to offer the course.

As of this date, students taking one of the following courses taught by the instructor of record in a traditional classroom setting may be assured that the course meets the Board's ethics requirement in order to apply for the Uniform CPA Examination. Board approved courses that are offered through distance education are also listed.

Instructors teaching a Board approved ethics course must comply with the requirements shown on the Educators tab of the Board's website.
