## **DISCUSSION AND ACTION**

4. Proposed Amendments to 19 TAC Chapter 239, Student Services Certificates

This item provides the State Board for Educator Certification (SBEC) an opportunity to discuss and propose amendments to 19 TAC Chapter 239, <u>Student Services Certificates</u>. The proposed amendments would update the rules to reflect current law and add specificity to the requirements relating to the school counselor certificate, school librarian certificate, educational diagnostician certificate, reading specialist certificate, and master teacher certificate.

5. Adoption of Review of 19 TAC Chapter 239, Student Services Certificates

Texas Government Code, §2001.039, establishes a four-year rule review cycle for all state agency rules, including State Board for Educator Certification (SBEC) rules. This item presents for SBEC approval the adoption of the review of 19 TAC Chapter 239, Student Services Certificates. The rules being reviewed provide requirements relating to the school counselor certificate, school librarian certificate, educational diagnostician certificate, reading specialist certificate, and master teacher certificate.

# 7. Proposed Repeal to 19 TAC Chapter 240, American Sign Language Certificate

This item provides the State Board for Educator Certification (SBEC) an opportunity to discuss and propose the repeal of 19 TAC Chapter 240, American Sign Language Certificate. Current rules for the American Sign Language Certificate, based on standards established for the Texas Examination of Educator Standards (TExES), are in 19 TAC §231.1, Criteria for Assignment of Public School Personnel, and §233.15, Languages Other Than English.

## 8. Adoption of Review of 19 TAC Chapter 240, American Sign Language Certificate

Texas Government Code, §2001.039, establishes a four-year rule review cycle for all state agency rules, including State Board for Educator Certification (SBEC) rules. This item presents for SBEC approval the adoption of the review of 19 TAC Chapter 240, American Sign Language Certificate. The rule being reviewed provides requirements relating to the American Sign Language certificate.

# 11. Adoption of Proposed Revisions to 19 TAC Chapter 241, Principal Certificate

This item provides the State Board for Educator Certification (SBEC) an opportunity to adopt, subject to State Board of Education (SBOE) review, the proposed revisions to 19 TAC Chapter 241, Principal Certificate. The proposed revisions would update the rules to reflect current law and add specificity to educator preparation and certification requirements relating to the principal certificate. Additional changes are recommended to 19 TAC §§241.20, Requirements for the Issuance of the Standard Principal Certificate, 241.25, Requirements for the First-Time Principal in Texas, and 241.35, Assessment Process Definition and Approval of Individual Assessments, since published as proposed.

14. Opportunity to Discuss Implications of Senate Bill 174 on 19 TAC Chapter 229, Accountability System for Educator Preparation

This item presents for discussion the impact of Senate Bill (SB) 174, 81st Texas Legislature, 2009, on 19 TAC Chapter 229, <u>Accountability System for Educator Preparation</u>, including the process for developing proposed revisions to Chapter 229. SB 174, which became effective June 19, 2009, requires the State Board for Educator Certification (SBEC) to assign educator preparation programs an accreditation status and allows the Texas Education Agency (TEA) to intervene in cases of low-performance. In addition, SB 174 requires the TEA to develop a website with consumer information to

assist teacher candidates in selecting an educator preparation program and school districts in hiring decisions.

# 15. Review of 19 TAC Chapter 245, Certification of Educators from Other Countries

Texas Government Code, §2001.039, establishes a four-year rule review cycle for all state agency rules, including State Board for Educator Certification (SBEC) rules. This item presents the review of 19 TAC Chapter 245, Certification of Educators from Other Countries. The rules being reviewed provide requirements relating to the issuance of a Texas educator certificate based on certification from another country.

## 16. Discussion of the Generalist: Grades 4-8 Certificate

This item provides the State Board for Educator Certification (SBEC) an opportunity to discuss concerns raised by some State Board of Education (SBOE) members regarding the SBEC approval of the Generalist: Grades 4-8 certificate. The concerns relate to a teacher who may be teaching in a content area where they may not have any college credits in that specific area on the transcript but were able to pass the certification examinations. The certificate has provided flexibility for school districts that need certified teachers to teach multiple subjects in the middle school.
