Dr. Richard Beauchamp, DSHS, handed out copies of the executive summary of the Health Consultation report, Midlothian Area Air Quality Part 1.

Dr. Beauchamp stated that DSHS had received a petition from a Midlothian resident in 2005 to study air emissions in Midlothian and its potential impact on human health

227 total chemicals were reviewed (VOCs, metals, and inorganics)

Over 92,000 measurements (samples) were reviewed

The Midlothian Air Quality report has been release for public comment. Anyone can submit written comments to DSHS from December 11, 2007 to February 11, 2008.
