

## **Deaf Interpreter Training**





## Arrested in America - Interpreting Interrogations & the Miranda Warning

Ben Hall, SC:L, NIC, C.S.C.

This training discusses the techniques used by law enforcement during interviews and interrogations and analyzes various examples of conceptually accurate interpretations of the Miranda Warning. Being arrested and interrogated is a tramatic experience.

Interrogators control not only the topics of discussion, but also the physical environment. Investigators observe the subjects' verbal and nonverbal responses to the issues presented. Accordingly, interpreters must be knowledgeable of these techniques in order to render accurate and faithful interpretations. This session also analyzes examples of conceptually accurate interpretations of the Miranda Warning and provides opportunities to incorporate these into one's work. The workshop format includes: video analysis, lecture, group discussion/activities, group/team work and feedback.

## BEN HALL RID SC:L/NIC/C.S.C.



Ben began his professional interpreting career in 1975 and obtained RID certification in 1980. Over the past 30 years, he freelanced, taught for 11 years at Columbus State Community College Interpreter Training Program, and coordinated interpreters for years for the Ohio Rehabilitation Services Commission. He served 13 years on the Registry of Interpreters for the Deaf (RID) Board, including five years as Region III Representative, four years as Vice-President, and four years as President. Ben also served as a member of the national RID – NAD National Council on Interpreting (NCI) which developed the new NAD-RID National Interpreter Certification (NIC) and new joint Code of Professional Standards. Ben is a member of the Ohio Supreme Court's Rules & Policy Subcommittee charged with developing standards, policies, and procedures affecting all language interpreters in Ohio.



## From Arrest to Conviction: Legal Ease for Interpreters

Buddy Bauer, SC:L, Texas BEI Level V/Court

This cause of action will make you an accessory to legal interpreting. There is nothing criminal about discussing and showing different ways to represent legal "speak in sign language", so long as it's done civilly. Heretofore and forthwith, the interpreter is the legal guardian of a clearly interpreted message, vis-à-vis judicial proceedings. Come and temporarily cohabitate with your aforementioned accomplices and learn to navigate courtroom and judicial terminology. To miss this would be objectionable and it would be negligence and a felonious violation to default this opportunity. How do you plead, guilty, not guilty or no contest?

Most people nowadays have been exposed to a lot of legalese, legal processes, etc. through television and other media. We all have an idea of what things mean and a paradigm for how it works. This for-fun, highly interactive workshop is going to tap into that incidental knowledge through the use of video tapes, games and interactive activities and develop skills to prepare you for legal interpreting.

## **Logical Reasoning for Court Interpreters**

Carla M. Mathers, Esq.

The presenter will review the roles, ethical provisions, statutory and case law provisions affecting court interpreters. The discussion will include a presentation of logical reasoning by which interpreters can convince administrators, courts and lawyers to hire the appropriate complement of interpreters for a given assignment. Participants will be able to state the three models of logical reasoning. Participants will be able to articulate in a logical fashion (major premise, minor premise to conclusion) justification for the providing various configurations of interpreters for a variety of scenarios. Comprehension and integration will be measured by in-class presentations requiring the analysis and presentation of arguments supporting various configurations for various assignments.



## Court & Legal Interpreter DECIDE: An Ethical Decision-Making Session

This presentation provides the framework of DECIDE to aid in making solid and systematic ethically-based decisions. With the addition of a mechanism to test interpreters' ethical decision-making knowledge and skills, interpreters are finding that what had previously been considered an intuitive process is difficult to articulate. This framework provides the foundation to externalize and articulate the decisions needing to be made to arrive at a sound ethical decision. This


framework also ensures a well-rounded approach to stakeholder analysis and helps interpreters to consider all factors involved. A self-analysis tool will be provided for participants to be able to gauge the effectiveness of responses to over 25 ethically-based scenarios for practice.

#### **Educational Objectives:**

- Understand the basic concepts behind ethics and making sound ethical decisions within context of court and legal settings
- Be able to articulate various processes related to identifying a conflict, evaluating stakeholder groups, developing possible solutions & evaluating the possible impacts to the stakeholder groups, determining the best approach and implementing and evaluating the approach selected
- Be able to apply the DECIDE framework to co-participant provided scenarios and 10 instructor provided courtroom ethical scenarios.

## **An Ethical Decision-Making Study Group**

### Lynne Wiesman

This study group will look at the ethical decision-making processes of interpreters in court and legal settings. This group is valid for 8 hours for BEI and RID in the area of court and legal studies and will qualify Deaf Interpreters for the required 8 hours to sit for the CDI test. This study group is asynchronous and has a flexible start and end date. Participants may begin the group at any time and must complete the requirements within 30 days.

Educational Objectives - Participants will be able to:

- · evaluate a situation as defined by the guidelines of DECIDE,
- develop a mnemonic to aid in recall of ethical tenants as needed,
- develop a script providing the basic framework to address ethical decisions more intuitively,
- · utilize the model to apply to ethical case studies,
- make decisions that are well thought out and based on solid judgment and reasoning.



## **English Proficiency Prep**

- develop a range of sentence, phrasal, and lexical usage that is register appropriate,
- develop an ability to externally and internally monitor English language usage.
